Bank in Surat looted in daring daylight robbery

In a daring daylight robbery, five masked men walked into the Vanz branch of the Bank of Maharashtra on the outskirts of Surat and were gone in a flash after cleaning out the cash vault of Rs 13.26

The entire operation carried out with clinical finesse was completed within five minutes as the CCTV grab retrieved from the bank shows. The targeted branch in Sachin area closely proximates the GIDC industrial

This is not the first case of bank robbery in the area. In June last year, a single masked man had similarly robbed the Surat District Cooperative Bank branch at Kadodara GIDC industrial estate near Surat of Rs 6.83

According to KN Damor, Joint Police Commissioner, Surat, five people, four of them sporting helmets and

motorcycles, entered the bank, closed the main entrance from inside and shepherded the staff and customers at gunpoint into a room. They forced the cashier to empty the vault, put it in a bag and left on the two bikes. The five entered the bank at 11.7 am and were out past 11.11 am as the time ticker on the CCTV grab shows. The two motorcycles, which were used to reach the bank and later make a swift getaway, were found abandoned some distance away at

That the five had been in town and planned the operation became clear after it was found that the two motorcycles had been stolen. The branch must have been under observation for there was no security guard, the police believes.

Damor said that a red alert has been ordered in the city as well as neighbouring disswitched from the bikes to autorickshaws also seemed to have changed their clothes.

As many as 80 types of medicines and 38 diagnostics tests were available for patients free of cost, he said and added that over 44 lakh patients had benefited from these AACs and over 20 lakh patients had undergone free tests in less than one year at these clinics.

Medicines of approximately Rs 30.25 crore had been provided to patients during the past one year, he said adding that each clinic had a medical officer, pharmacist, clinic assistant and helper. All the clinics were IT-based with the provision of tablets for patient registration, prescrip-

tion and dispensation of med-

Recounting the other significant achievements in the health sector, the health minister said that the state government had appointed 300 house surgeons to strengthen the emergency services at district and sub-divisional hospitals, while 200 Post-PG students had been bonded to serve as contractual medical officers with the state health department.
