### Declaration of Voting Results in respect of Shareholders' Resolution passed on November 19, 2023

In terms of Section 110 of the Companies Act, 2013 read with Rules 20 & 22 of the Companies (Management and Administration) Rules, 2014 read with General Circular No. 09/2023 dated September 25, 2023 and the previous circulars on COVID-19 related relaxations issued by Ministry of Corporate Affairs (MCA) applicable in this regard, IDBI Bank provided facility of e-voting to the Members vide Bank's Postal Ballot Notice dated October 16, 2023 sent only through electronic mode on October 20, 2023 to those Members whose e-mail addresses were registered with the Bank/Depositories on October 13, 2023 towards passing special resolution for appointment of Shri Ajay Prakash Sawhney (DIN:03359323) as Independent Director not liable to retire by rotation, on the Board of the Bank for a term of 4 consecutive years w.e.f. August 28, 2023.

Members voted exclusively through e-voting from Saturday, October 21, 2023 at 9:00 AM IST to Sunday, November 19, 2023 at 5.00 PM IST, being the last date specified for voting. The Board had appointed Ms. Aparna Gadgil of M/s. S.N Ananthasubramanian & Co. as Scrutinizer to scrutinize the votes cast through e-voting. Scrutinizer submitted her Report of the total votes cast in favour or against the Resolution, in terms of the said Rule 20 of the Companies (Management and Administration) Rules, 2014.

We are pleased to present the report on the Postal Ballot conducted by **IDBI Bank Limited** ("the Bank") seeking consent of its Members for the Special Resolution as contained in the Notice of Postal Ballot dated **October 16, 2023.** 

- 1. In terms of provisions of Section 110 of the Companies Act, 2013 ("the Act") read with Companies (Management and Administration) Rules, 2014, we were appointed as the Scrutinizer by the Bank on **September 30, 2023** to conduct the Postal Ballot as contained in the Notice dated **October 16, 2023** ("Postal Ballot Notice").
- 2. In terms of Sections 110 and 108 of the Companies Act, 2013, and all other applicable provisions, if any, of the Act read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 and in accordance with the relevant circulars issued by Ministry of Corporate Affairs ("MCA") from time to time, in relation to *inter-alia* "Clarification on passing of Ordinary and Special resolutions by companies under the Companies Act, 2013" read with rules made thereunder, Members' approval was sought for the Special Resolution as contained in the Postal Ballot Notice through e-voting only.

#### 3. Notice of the Postal Ballot

- 3.1. The Bank has informed that, on the basis of the Register of Members and the List of Beneficial Owners made available by the Depositories viz., National Securities Depository Limited ("NSDL") and Central Depository Services (India) Limited, as on Friday, October 13, 2023 ("the cut-off date"), the Bank had completed the dispatch of Postal Ballot Notice on October 20, 2023 through e-mail to 5,64,509 Members who had registered their email-ids with the Bank/ Depositories/ Depository Participants/ Registrar and Share Transfer Agent.
- 3.2. The Bank had hosted the Postal Ballot Notice on its website and the website of KFin Technologies Limited (e-voting Agency) and also intimated the same to BSE Limited and National Stock Exchange of India Limited on, **October 20, 2023.**
- 3.3. Pursuant to Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 and the relevant MCA Circulars, an advertisement regarding the Postal Ballot was published on October 21, 2023 in all editions of Financial Express (English Newspaper) and Loksatta (Marathi Newspaper).
- In terms of the aforesaid notice, Members were required to convey their assent or dissent, only through e-voting system, on e-voting platform provided by KFin Technologies Limited (Kfintech) from 9:00 a.m. (IST) on Saturday, October 21, 2023, till 5:00 p.m. (IST) on Sunday, November 19, 2023.
- 5. Members' demographic details and voting rights and voting pattern thereafter were downloaded by us from the e- voting platform provided by Kfintech.
- 6. After the scrutiny of the votes cast, all the votes cast by the Members were found to be valid;
