Please note that the Company has received an Order on November 21, 2024 at 02:00 p.m., from Assistant Commissioner of Central Tax, Ameerpet GST Division, Hyderabad GST Commissionerate at Hyderabad Branch, raising a GST demand of ₹ 2,41,82,080/- , Interest of ₹ 1,47,485/- and levying penalty of ₹ 2,64,01,686/- for the period July 2017 to March 2018 under Section 74 of the Central Goods and Services Tax Act, 2017. The Company would pursue an appeal with Appellate Authorities/ evaluate other legal options against the said Order.
