चीनचा भारताला इशारा?; हिमालयातील शिखरांवर ताबा मिळवण्याचा केला सराव

बीजिंग, दि. २७ (वृत्तसंस्था): एकीकडे जगाचे लक्ष अफगाणिस्तानमधील परिस्थितीकडे लागले असताना दुसरीकडे चीनने आपल्या सैन्याचा युद्ध सराव सुरूच ठेवला आहे. चिनी सैन्याने तिबेटमध्ये हिमालयातील शिखरांवर ताबा मिळवण्याचा सराव केला. या युद्ध सरावाचा हेतू भारताला इशारा देण्यासाठी होता, असेही तज्ज्ञांनी म्हटले आहे. याआधी गलवान खोऱ्यात झालेल्या संघर्षानंतर भारतीय जवानांनी चिनी सैन्याला धोबीपछाड देत कैलास रेंजमधील शिखरांवर ताबा मिळवला होता. त्यामुळे चीनला धक्का बसला होता. भारतीय जवानांच्या या कामगिरीचा चिनी सैन्य अधिकाऱ्यांनी धसका घेतला. त्यानंतर त्यांनी शिखर ताब्यात घेण्याच्या सरावावर भर दिला असल्याचे म्हटले जाते. काही दिवसांपूर्वी हा युद्ध सराव झाला. साउथ चायना मॉर्निंग पोस्टने दिलेल्या वृत्तानुसार भारतालगतच्या सीमा भागातील चीन लष्कराच्या पश्चिम थिएटर कमांडने आपल्या सैन्याच्या तुकडीला एकत्र केले आणि त्यांना दोन गटात विभागले. दोन दिवस आणि एक रात्र सुरू असलेल्या या युद्ध सरावा दरम्यान चीनच्या पीपल्स लिबरेशन आमींने (पीएलए) शिखरांवर तोफ डागली. त्याशिवाय मोठ्या प्रमाणावर गोळीबार आणि इलेक्ट्रोमॅग्नेटिक हल्ले देखील करण्यात आले. या युद्धसरावात शत्रूच्या हालचालींवर देखरेख ठेवणे, हेरगिरी करणे आर्दीचाही सराव करण्यात आला. या दरम्यान १२ जवानांच्या एका गटाने ६१०० मीटरपर्यंत चढाई केली. जेणेकरून हल्ल्यासाठी योग्य माहिती संकलित करता येऊ शकेल. त्यानंतर चिनी तोफांनी योग्य ठिकाणी मारा करण्यास सुरुवात केली. या युद्धसरावा दरम्यान एक ड्रोन एअरक्राफ्ट पाडण्याचाही सराव करण्यात आला. ड्रोनची दिशाभूल करण्यासाठी इलेक्ट्रोमॅग्नेटिक शस्त्रांचाही वापर करण्यात आला. काही तास गोळीबार, हेलिकॉप्टरमधून हल्ले, स्नापरचा वापर करण्यात आला. मकाऊ येथील एका चिनी विश्लेषकांनी सांगितले की, हा युद्ध सराव तिबेटमध्ये असणाऱ्या सैनिकांची तयारी दर्शवते. तर, आणखी एक तज्ज्ञ झोउ चेनमिंग यांनी सांगितले की, या सरावात ब्लू आर्मी म्हणून दुसरा गट होता. या गटाचा अर्थ भारतीय लष्कर म्हणून होता. चिनी सैन्य युद्धासाठी तयार आहे, हे दाखवण्यासाठी हा युद्ध सराव करण्यात आला.

काबूल विमानतळावरून वाहतूक पुन्हा सुरू; स्फोटातील मृतांची संख्या वाढली

काबूल, दि. २७ (वृत्तसंस्था) : काबूल आंतरराष्ट्रीय विमानतळावरून पुन्हा एकदा विमान सेवा सुरू करण्यात आली गुरुवारी संध्याकाळी झालेल्या आत्मघाती हल्ल्यानंतर विमान सेवा सुरक्षितेच्या कारणास्तव स्थगित करण्यात आली. काही तासानंतर विमान सेवा पुन्हा सुरू करण्यात आली. गुरुवारी मृतदेहांचा खच पडलेल्या ठिकाणी देशाबाहेर पडण्यासाठी धडपडणाऱ्या अफगाण नागरिकांची गर्दी दिसून आली. तर, स्फोटातील मृतांची संख्याही वाढली आहे. काबूलमधील स्थानिक माध्यमांनी दिलेल्या माहितीनुसार, शुक्रवारी सकाळपासून विमान सेवा पुन्हा सुरू करण्यात आली. टोलो न्यूजने दिलेल्या वृत्तानुसार, आत्मघाती हल्ल्यानंतरही विमानतळ परिसरात मोठी गर्दी दिसून आली. गुरुवारी झालेल्या स्फोटातील मृतांची संख्या १०० हून अधिक झाली आहे. यामध्ये १३ अमेरिकन जवानांचाही समावेश आहे. अफगाणिस्तानमधील वृत्तवाहिनी टोलो न्यूजचे पत्रकार अब्दुल हक ओमेरी यांनी काबुल विमानतळाबाहेरील एक व्हिडिओ ट्विट केला आहे. या व्हिडिओत, गुरुवारी झालेल्या आत्मघाती हल्ल्याच्या घटनास्थळी अफगाण नागरिकांनी मोठी गर्दी केली असल्याचे दिसून आले. दोन दशकानंतर अमेरिका अफगाणिस्तानमधून माघारी जाणार आहे. अमेरिका ३१ ऑगस्टपर्यंत आपले सैन्य माघारी घेणार आहे. मात्र, गुरुवारी झालेल्या हल्ल्यानंतर आयएसआयएस-के या दहशतवादी संघटनेला प्रत्युत्तर देणार असल्याचे अमेरिकेने

काश्मीर मोहिमेसाठी जैश-ए-मोहम्मदच्या प्रमुखाने घेतली तालिबान्यांची भेट!

नवी दिल्ली, दि. २७ (वृत्तसंस्था) : तालिबानने अफगाणिस्तानचा ताबा मिळवल्यानंतर जगात चिंतेचे वातावरण आहे. तालिबानमुळे दहशतवादाची मुळे घट्ट होतील, अशी चिंता जगाला लागली आहे. दरम्यान भारतासाठी चिंतेची बातमी आहे. पाकिस्तानस्थित दहशतवादी संघटना जैश-ए-मोहम्मदचा मौलाना प्रमुख मसूद अजहर ऑगस्टच्या तिसऱ्या आठवङ्यात तालिबानने अफगाणिस्तानचा ताबा घेतल्यानंतर कंधारमध्ये होता. त्याने जम्मू-काश्मीरमध्ये दहशतवादाला खतपाणी घालण्यासाठी तालिबानची मदत मागितल्याची माहिती मिळत आहे. मौलाना मसूद अजहर त्याचा भाऊ अब्दुल रौफ अजहर आणि मौलाना अम्मर यांच्यासह कंधारमध्ये होता. मसूद अजहरने राजकीय आयोगाचे प्रमुख मुल्ला अब्दुल गनी बरदार यांच्यासह तालिबान नेत्यांची भेट घेतली. मसूदने काश्मीर खोऱ्यात जेईएमच्या कारवायांसाठी तालिबानची मदत मागितली इंडीया टुडेने सूत्रांच्या हवाल्याने ही माहिती दिली आहे. यापुर्वी दहशतवादी मसूद अजहरने अमेरिकेच्या पाठिंब्यावरील अफगाण सरकार पडल्याबद्दल आनंद व्यक्त केला होता. 'मंझिल की बाजू' नावाच्या लेखात, जैशच्या संस्थापकाने अफगाणिस्तानातील मुजाहिदीनच्या विजयाबद्दल आभार मानले होते. या लेखात मसूदने असाही दावा केला होता की, अफगाणिस्तानातील एक किंवा दोन प्रांतातील प्रमुख किंवा उपप्रमुखांची जबाबदारी जैशला दिली जाऊ शकते. याशिवाय, त्यांनी जैशच्या सदस्यांना भविष्यात काश्मीरसाठी तयार राहण्यास सांगितले होते. शरिया या मुस्लिम कायद्याबाबत तालिबान आणि जैशची विचारसरणी समान आहे. जैश-ए-मोहम्मद जम्मू-काश्मीरमध्ये दहशतवादी कारवाया करण्यासाठी सिक्रय असते. मसूद अजहरने १९९९ मध्ये जैश-ए-मोहम्मदची स्थापणा केली होती. पाकिस्तानी दहशतवाद्यांनी अपहरण केलेल्या इंडियन एअरलाइन्सच्या फ्राइट घ्ण ८१४ मध्ये प्रवाशांच्या सुरक्षेच्या बदल्यात मसूद अझहरला भारतीय तुरुंगातून सोडण्यात आले. काठमांडूहून लखनौला जात असताना विमानाचे अपहरण करण्यात आले होते. त्यानंतर हे विमान अफगाणिस्तानातील कंधार येथे नेण्यात आले, जिथे त्या वेळी तालिबानची सत्ता होती. अपहरण झालेले विमान कंधारमध्ये उतरल्यानंतर लगेचच, तालिबान्यांनी एअरबसभोवती एक वर्तुळ तयार केले जेणेकरून भारत सरकारने मसूद अजहरसह दहशतवाद्यांची सुटका होईपर्यंत ते परिस्थितीवर नियंत्रण ठेवतील.

ई-श्रम पोर्टल झाले सुरु; देशात प्रथमच ३८ कोटी असंघटित कामगारांना होणार फायदा

नवी दिल्ली, दि. २७ (वृत्तसंस्था) : श्रम आणि रोजगार मंत्री भूपेंद्र यादव यांनी गुरुवारी ई-श्रम पोर्टलचा शुभारंभ केला. श्रम आणि रोजगार आणि पेट्रोलियम आणि नैसर्गिक वायू राज्य मंत्री रामेश्वर तेली यांच्या उपस्थितीत ते राज्य/केंद्रशासित प्रदेशांकडे हस्तांतरित केले. देशाच्या इतिहासात प्रथमच ३८ कोटी असंघटित कामगारांची नोंदणी करण्यासाठी एक प्रणाली तयार केली जात आहे. ती केवळ त्यांची नोंदणी करणार नाही तर केंद्र आणि राज्य सरकारांमार्फत राबविल्या जाणाऱ्या विविध सामाजिक सुरक्षा योजनांचे लाभ पुरवण्यासाठीही उपयुक्त ठरेल,' असे कामगार मंत्री म्हणाले.

या प्रसंगी भूपेंद्र यादव यांनी eSHRAM पोर्टलवरील प्रत्येक नोंदणीकृत असंघटित कामगाराला २ लाख रुपयांचे अपघाती विमा संरक्षण मिळणार आहे. एखाद्या कामगाराने eSHRAM पोर्टलवर नोंदणी केली असेल आणि त्याचा अपघातात मृत्यू झाला किंवा कायमस्वरूपी अपंगत्व आले तर २ लाख रुपये आणि अंशत: अपंगत्वासाठी १ लाख रुपये मिळण्यासाठी तो पात्र असेल आणि कामगारांच्या कल्याणासाठी सरकार नेहमीच वचनबद्ध आहे. श्रम आणि रोजगार आणि



पेटोलियम आणि नैसर्गिक वायू राज्यमंत्री रामेश्वर तेली यांनी ई-श्रम पोर्टलची वैशिष्ट्ये अधोरेखित करताना सांगितले की ही सर्व असंघटित कामगारांच्या राष्ट्रीय डेटाबेसची निर्मिती आहे. या मोहिमेचा भाग होण्यासाठी आणि सर्व असंघटित कामगारांना ई-श्रम पोर्टलवर नोंदणीकृत करण्यासाठी आणि 'छूटेगा नहीं कोई कामगार, योजनाएं पहुचेंगी सबके द्वार' हे भारत सरकारचे अत्यंत आवश्यक ध्येय पूर्ण करण्यासाठी भागीदार बनण्याचे त्यांनी देशातील लोकांना आवाहन केले. या प्रसंगी, दोन्ही मंत्र्यांनी अजमेर, दिब्रूगढ, चेन्नई आणि वाराणसी येथील कामगारांशी संवाद साधला, जे कॉमन सर्व्हिस सेंटरमधून व्हर्च्युअली जोडले होते. त्यांनी त्यांचे अनुभव आणि अपेक्षा सांगितल्या, यादव आणि तेली यांनी त्यांना अपघाती विमा योजनांची माहिती दिली आणि पोर्टलवर नोंदणी करण्याचे फायदे स्पष्ट केले.

नवी दिल्ली, दि. २७ (वृत्तसंस्था) : आताच्या घडीला देशात पेट्रोल आणि डिझेलचे दर सार्वकालिक उच्चांकावर आहेत. देशातील १७ राज्ये आणि केंद्राशासित प्रदेशात पेट्रोलचा भाव १०० रुपयांच्याही वर गेला आहे. डिझेलची सर्वोच्च किमतीवर आहे. पेट्रोल आणि डिझेलला पर्यायी इंधनावर भर देण्याचा केंद्र सरकारकड्न दिला जात आहे. या पार्श्वभूमीवर केंद्रीय रस्ते वाहतूक आणि महामार्ग मंत्री नितीन गडकरी यांनी वाहन निर्माता कंपन्यांना डिझेल इंधनावर चालणाऱ्या वाहनांचे उत्पादन आणि विक्री कमी करून पर्यायांवर भर देण्याची

ऑटो उद्योगाची संघटना असलेल्या सियामच्या वार्षिक परिषदेला संबोधित करताना नितीन गडकरी म्हणाले की, सरकार फ्लेक्सिबल इंजिनांना प्रोत्साहन देण्यासाठी वचनबद्ध आहे, जे ग्राहकांना १०० टक्के पेट्रोल किंवा १०० टक्के बायो-इथेनॉलवर चालणाऱ्या वाहनांचा पर्याय देईल, असे गडकरी यांनी नमूद केले. वाहन उत्पादकांना डिझेल इंजिन वाहनांचे उत्पादन आणि विक्री कमी करण्याचे आवाहन करतो. डिझेलमुळे होणारे प्रदूषण पर्यावरण आणि मानवी आरोग्यासाठी अत्यंत धोकादायक आहे. उद्योगाने पर्यायी इंधन तंत्रज्ञानाला प्रोत्साहन दिले पाहिजे आणि पर्यायी इंधनासाठी संशोधन आणि विकासावर खर्च केला पाहिजे, अशी अपेक्षा गडकरी यांनी व्यक्त केली. असे केल्याने आयात बिल कमी होईल आणि पर्यावरण संरक्षणासह शेतकऱ्यांचे उत्पन्न वाढेल. भारताच्या जीडीपीमध्ये ऑटोमोबाईल क्षेत्राचा वाटा सध्याच्या ७.१ टक्क्यांपेक्षा १२ टक्क्यांपर्यंत वाढला पाहिजे आणि रोजगाराच्या दृष्टीने या क्षेत्राचे योगदान सध्याच्या ३७ मिलियनवरून ५० मिलियनपर्यंत वाढले पाहिजे

चांगली वाढ होऊ शकते. रिपोर्ट्सनुसार, सरकार जून महिन्यासाठी महागाई भत्ता निश्चित करणार आहे. मात्र. अदयाप या संदर्भात सरकारकडन कोणतेही माहिती देण्यात आली नाही. ऑल इंडिया कंज्यूमर प्राइस इंडेक्सच्या (AICPI) जूनच्या आकडेवारीनुसार जी माहिती समोर आली आहे. त्यानुसार, महागाई भत्त्यात ३ टक्क्यांनी वाढ होऊ शकते.

दरम्यान, केंद्रीय कर्मचारी सध्या २८ टक्के महागाई भत्ता दिला जात आहे. हा महागाई भत्ता त्याच्या जुलैच्या पगाराशी
