The Chairman of the 9th Annual General Meeting of the Members of Mystic Electronics Limited held on Wednesday, 30th day of September, 2020 at 12:00 p.m. through Video Conferencing ("VC")/Other Audio Visual Means ("OAVM").

Dear Sir,

I, Arvind Baid, Practicing Chartered Accountant, Proprietor of M/s. Arvind Baid & Associates, Mumbai, had been appointed as the Scrutinizer by the Board of Directors of Mystic Electronics Limited pursuant to Section 108 of the Companies Act, 201 3 ("the Act") read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended, to conduct the remote evoting and the e-voting during AGM in a fair & transparent manner, in respect of the below mentioned resolutions proposed at the 9th Annual General Meeting ("AGM") of Mystic Electronics Limited on Wednesday, 30th September, 2020 at 12:00 p.m. through Video Conferencing ("VC")/Other Audio Visual Means ("OAVM").
