Pursuant to Regulation 30 of SEBI LODR, this is to inform you that Mr. Abhesh Verma, Chief Executive Officer (Key Managerial Personnel under the Companies Act, 2013) of the Company and HT Digital Streams Limited (material WOS) has decided to step-down from his role as CEO of both the companies w.e.f. 30<sup>th</sup> June, 2020 (closing business hours), as he is unable to devote adequate time for his role as CEO (KMP) in view of his extended stay in the United States of America (USA), due to international travel restrictions.

Consequent to above, the Board of Directors of the Company at its meeting held today i.e. July 1, 2020, on the recommendation of Nomination & Remuneration Committee of the Company viz. Digicontent Limited, approved the appointment of Mr. Puneet Jain as CEO (KMP) w.e.f. July 16, 2020 or such other date as may be mutually agreed.
