Sir,

With reference to the subject cited above and in pursuance of the proposal for approval of recommendations for customized incentives to M/s Gulshan Polyols Pvt. Limited, to set up a plant of capacity 250KLPD for the manufacturing Ethanol with an investment of Rs.200.00 Crores (Rupees Two Hundred Crores) at IGC Matia , Goalpara District and creation of permanent employment not less than 200 nos., I am directed to convey the approval of the Hon'ble Cabinet that “ *in addition to the eligible benefits under Assam Ethanol Production Promotion Policy 2021, the unit shall be provided an incentive of Rs.2/- per litre of bio-ethanol initially for three years.
