Report on the audit of the Financial Results

Opinion

Basis for Opinion

The Board of Directors is responsible for overseeing the Company's financial reporting process.

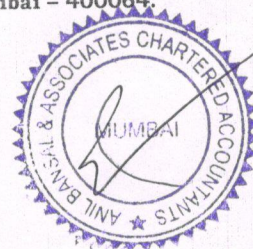
Auditor's Responsibilities

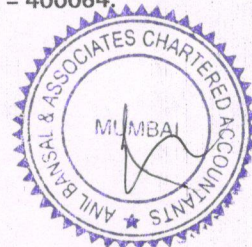
fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control;

matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.


b) Review of the Financial Results
