

Detailed Rationale

The revision in ratings is due to recent delays in servicing its obligation in non-convertible debentures (facilities not rated by Infomerics). Infomerics has received the information from publicly available data. Further, Infomerics notices significant stretch in its liquidity marked by elongated receivable position and full utilization of its bank facilities.
