Security experts believe a resurgence in militant attacks, which have rocked India's northeast in recent months, have come about as militants work to regroup in China's borderlands with Myanmar, and expect more to follow even as elections to Manipur and peace talks in Nagaland are held.

Naga splinter groups impatient with stalled talks as well as rebel Manipuri groups who have a stake in disrupting upcoming elections to the state assembly, are believed to be regrouping in the borderlands of China's Yunnan province and Myanmar, taking advantage of the turmoil in the latter by using works, which may accompait as a transit corridor. ny the democratic process.

NGT pulls up retiring Raj chief secy

The National Green Tribunal has pulled up Rajasthan Chief Secretary Niranjan Arya not filing an affidavit, nor appearing through video-conferencing, on the pretext of his retirement in January, on a notice on discharge of untreated sewage and industrial effluents on agriculture lands in a village in Bikaner.

A Bench headed by NGT chairman Justice Adarsh Kumar Goel, a former Supreme Court judge, took offence at Arya not responding to its notice. Justice Goel said: "If a Chief Secretary is to retire, he cannot stop working before retirement. If he has such a disability, in the interest of administration, he should make way for others who can perform.'

It directed in an order on January 6 that both "current and incoming Chief Secretaries, Rajasthan to take immediate remedial measures in the light of above observations and in compliance of directions in the order dated September 21, 2021, in coordination with concerned officers and file a report of compliance within two months by e-mail,"

It took offence to the fact that contrary to the timeline fixed by the Supreme Court, requiring requisite treatment plants to be placed by March 31, 2018, long timelines have been proposed without any accountability for the delay.

"In fairness, relevant data should have been given or at least a statement should have been made that no untreated sewage was being discharged.'

This monitoring was directed by the Tribunal to be at the level of the chief secretary but nothing is mentioned on this aspect, the NGT underlined.

"That is why the Tribunal intended to interact with the chief secretary to find out ways and means for ensuring compliance with the law and directions of the Supreme Court particularly to cut down time taking process in this particular case and replicate to other places also," the bench
