Mr. Nitin Naresh, Company Secretary welcomed all Members, Directors, and other invitees to the 08th Annual General Meeting (AGM) of the members of SBL Infratech Limited ('the Company') held on Saturday, 30th September, 2023 at 12:00 Noon (IST) through Video Conferencing ("VC") / Other Audio-Visual Means ("OAVM").


The Company Secretary informed that Statutory Registers, Annual Report and other documents were made available for inspection by the Members.
