मुंबई: ‘हमारे बारह’ चित्रपट पाहिल्यानंतर सकुंदरदर्शनी तयार आपल्याला कुराण किंवा मुस्लिम मान्यतेबाबत काही अक्षेप्राह असू शकते. असे निरीक्षण नोंदवल्यानंतर उच्च न्यायालयाने बुधवारचा चित्रपटाच्या प्रदर्शनाचा मार्ग मोकळे केला. अक्षेप्राह दुर्भेदकता या तवारी चित्रपट निर्मात्यांनी दाखवल्यानंतर न्यायालयाने चित्रपटाच्या प्रदर्शनाला

हिर्वा कंदील दाखवला. त्यावेळी, अर्धमासिक दूरधर्मात जलक प्रसिद्ध केल्याबद्दल चित्रपट निर्मात्यांना पाच लाख रुपये दंड ठोठावला आणि ही रक्कम याच कंदीलच्या परतीच्या धर्माद्वय संस्थेला देण्यात हद्दपुन केल्याचे आदेश दिले. हा चित्रपट ७ जून रोजी प्रदर्शित होणार होता. मात्र, त्यानंतर विवादातून वदामुळे नंतर तो १४ जून रोजी प्रदर्शित केला जाणार होत. न्यायालयाने परवानगी दिल्यानंतर आता ते २१ जून रोजी झळकणार

आहे. हा चित्रपट कुराणचे विस्तारित आणि इस्लामी धर्मा व मुस्लिम समुदायाचा अपमान करणारा असल्याचा दावा करून चित्रपटाच्या प्रदर्शनाला बंदी घालण्याच्या मार्गासाठी याचिका करण्यात आली होती. न्यायालयीन बळिष्ठ कुराणवाला आणि न्यायालयीन फिर्दाव घेण्यात आल्या यांच्या खंडपीठातने चित्रपट पाहिले आणि त्यांना काही बदल सुचवले. ते बदल निमित्त आणि याचिकाकर्ते दोषांनीही मान्य केले.

गोखले-बर्फीवाला पुलांच्या जोडणीत यश

झाली. मात्र अंधेरी पारंपच दिसला असलेला बर्फीवाला पूल आणि गोखले पूल यांनी पातळी वरखाली झाली होती. त्यामुळे बर्फीवाला पूल बंद ठेवावा लागला होता. पुलांमधुन अंतर पडल्यामुळे महापालिकेला टीकाही सहन करावी लागली. पूल जोडण्यासाठी प्रशासनाने मुंबई अधिकाऱ्यांनी शिफारस केली. त्यांच्या सल्ल्यावरून असे जावून पुलाचा काही भाग वर खेचून पातळी समतल

करण्याचे काम अंमल बघण्यात आले. हे काम ३० जूनपर्यंत पूर्ण करण्याचे उद्दिष्ट असून त्यानंतर पुलावर २४ तासांसाठी शिफारस च्याची (लॉट टेंडर) करण्यात येईल. त्यानंतर पुनः जावून पुलाची खुला होईल. काही दिवसांपुढी महापालिका आयुक्त बाबू गगगाणी यांनी या कामाची पाहणी करून नियोजित कालावधीत काम पूर्ण करण्याबाबत अतिरिक्त आयुक्त (प्रकल्प) अभिषेक वामर यांना सूचना दिल्या होत्या.

मुंबईतील पाणीपुरवठ्याचे पर्यायी प्रकल्प कागादवरच

(यान १ वरून)

१० टक्के पाणीपुरवठा लागू करण्याचा निर्णय मुंबई महानगरपालिका प्रशासनाने घेतला आहे. मुंबई महानगरपालिकेत पाणी, विविध-निष्ठागुणवत्ता महानगरपालिका व इतर गावांना करण्यात येणाऱ्या पाणीपुरवठ्याचे १० टक्के कपात लागू आहे. समाधानकारक पत्रव्यवहाराने जलावपातील पाणीपुरवठा साठ्यामध्ये सुधारणा होईपर्यंत ही पाणीपुरवठा लागू राहणार आहे. पावसाळ्यात धरणे काढून काढली होती. तरीही हा पाणीपुरवठा बंद पुरोमास झाला आहे. त्यामुळे मुंबई महापालिकेला पाणीपुरवठ्यासाठी पर्यायी व्यवस्था करावी लागणार आहे.

मुंबई महापालिकेने गाराई, पिंजाळ व दपगमात असे तीन प्रकल्प हाती घेतले होते. या सळ्या प्रकल्पचे काम रडवले आहे. गाराई धरणामुळे मोठ्या प्रमाणावर झाडे निष्ठागुणवत्ता असल्यामुळे हा प्रकल्पही पाहिलेले मुंडाळल्या होत. मात्र सध्या पाहिलेले हा प्रकल्प नेण्याचे ठरवले आहे. त्याकरिता गाराई धरणच्या जागेवरिल झाडांची पुन्हा मोजणी करण्याचा निर्णय पालिका प्रशासनाने घेतला आहे. ही झाडे हटवण्यासाठी यन विभागाची परवानगी मिळवण्याकरिता पाठपुरावा सुरू असल्याची माहिती पालिकेचे अधिकृत आयुक्त अभिषेक वामर यांनी दिली. पाण्याची वाढती मागणी पूर्ण करण्यासाठी पालिकेने मनोरी येथे निष्ठागुणवत्ता प्रकल्प उभारण्याची योजना केली होती. मात्र या प्रकल्पही निविदेच्या पातळीवर तज्ज समितीच्या शिफारशीनुसार
