# Home assures House: No decision yet on NRC

**EXPRESS NEWS SERVICE** New Delhi, February 4

WITH PROTESTS AGAINST the Citizenship Amendment Act (CAA) and proposed National Register of Citizens (NRC) marking two months next week, the government reiterated in the Lok Sabha Tuesday that it has not taken any decision on preparing a nationwide register.

It also moved to quell fears over personal data being collected for the pre-Census exercise of updating the National Population Register (NPR) by making clear that no document will be collected during the updation — and that providing Aadhaar number during the exercise is voluntary.

Replying to a written question on NRC, MoS (Home) Nityanand Rai said: "Till now, the government has not taken any decision to prepare the National Register of Indian Citizens at the national level."

In another reply, Rai said: "No document is to be collected during the updation of NPR."

The passage of the CAA in Parliament on December 11 has triggered protests and fears that it would lead to a nationwide implementation of the NRC. It led at least eight Opposition-ruled states to declare that they would not implement the CAA.

These states have also opposed the NPR updation move, which has triggered fears that the central government would use the data collected to implement the NRC. The NPR is slated will be updated between April and September, 2020. The Census will be conducted from February 9-28, 2021.

The government is currently in discussion with the states that expressed concerns over the preparation of the NPR. MoS Rai said that an instruction manual for enumerators and supervisors has been prepared, and made clear

"The NPR updation will be undertaken through house to house enumeration for collection of specified particulars relating to each family and individual. The respondent has to provide the information true to the best of his knowledge and belief. Aadhaar Number is collected voluntarily," he

Rai also pointed out that the "NPR was first prepared in 2010 and updated in 2015". PTI adds: West Bengal Chief

Minister Mamata Banerjee has appealed to her counterparts in the northeast and non-BJP states to carefully study the NPR form, its questions and criteria, before taking a decision on updating it.

Dubbing the exercise as "a dangerous game", Banerjee said the form, which seeks birth details and residential proof of parents, was a precursor to the NRC.

The Kerala government has announced that it will implement the Census exercise but will not cooperate with the NPR. "As the NPR is a process that leads to the NRC, there is a sense of fear among the people. If the NPR and NRC are implemented in Kerala, it will lead to widespread anarchy. That is the experience of the state where the NRC was implemented," said the Chief

Minister's Office. So far, a Supreme Courtmonitored exercise of updating the NRC was carried out only in Assam. The final NRC, a list of Assam's residents published on August 31, 2019, excluded 19 lakh people.
