We did not review the financial results of **INDO EDUCATION PRIVATE LTD.** (subsidiary) included in the Statement whose financial information reflects total revenue of (1.92 lacs) and 0.83 lacs, total net loss after tax of Rs. 5.15 lacs Rs. 8.58 lacs, total comprehensive loss of Rs. 5.15 lacs and Rs. 8.58 lacs, for the quarter and year-to-date period ended on 31st December 2020, respectively as considered in the Statement. These financial results have been reviewed by other auditors whose review report has been furnished to us by the management, and our conclusion in so far as it relates to the amounts and disclosures included in respect of this subsidiary is based solely on the review report of such other auditors and the procedures performed by us as stated above.


Our conclusion is not modified in respect of this matter with respect to our reliance on the work done by and the reports of the other auditors.




