### <u>Applicability of the provisions pertaining to Corporate Governance on Bazel</u> <u>International Ltd.for the Quarter ended on 30<sup>th</sup> June, 2023</u>

As per **Regulation 15 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015**, (hereinafter referred to as 'The Listing Regulations')these provisions of Chapter IV of the said Listing Regulations, 2015 shall be applicable to all listed Companies whose specified securities are listed on any recognized stock exchange either on the main board or on SME Exchange or on institutional growth platform. However, as per Regulation 15(2) of these listing regulations, the compliance with the corporate governance provisions as specified in Regulations 17, 17A, 18, 19, 20, 21, 22, 23, 24, 24A, 25, 26, 27 and clauses (b) to (i) and (t) of sub-regulation (2) of Regulation 46 and Para C, D and E of Schedule V shall not be mandatory, for the time being, in respect of the following class of companies:

- A. The listed entity having Paid up Equity Share Capital not exceeding Rs.10 Crore and Net Worth not exceeding Rs. 25 Crore, as on the last day of the previous financial year (31<sup>st</sup> March, 2023 in this case);
- B. The Listed Entity which has listed its specified securities on the SME Exchange.

Further, it is provided that where the provisions of regulations specified becomes applicable to a listed entity at a later date, such listed entity shall comply with the requirements of those regulations within 6 months from the date on which the provisions became applicable to the listed entity.

In view of the aforesaid, I would like to apprise you that provisions stipulated under Regulations 17, 17A, 18, 19, 20, 21, 22, 23, 24, 24A, 25, 26, 27 and clauses (b) to (i) and (t) of sub-regulation (2) of Regulation 46 and Para C, D and E of Schedule V of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 are applicable on Bazel International Ltd.("the Company") as its paid-up equity share capital and net worth doesn't exceeds the prescribed threshold limits as on the last day of the previous financial year.

It is to be noted that Paid-up Equity Share Capital and Net worth as on the last day of the previous financial year ended on  $31^{st}$  March, 2022 are Rs. 1.95 Crore and Rs. 43.41 Crores respectively.
