Consequent to the sad demise of Late Keshub Mahindra and Late Sudha Mahindra, 18,90,176 shares held by them in the Company were first transmitted to the Nominees / Surviving Joint Holders of the demat accounts held by Late Keshub Mahindra and Late Sudha Mahindra, namely, Uma Malhotra, Leena Labroo & Yuthica Mahindra, on 26th December, 2023 by way of First Leg of the Transmission.

Immediately thereafter i.e. on 26th December, 2023 itself, a part of the said 18,90,176 shares have been acquired by the Legatees as per the Wills of Late Keshub Mahindra and Late Sudha Mahindra, namely, Uma Malhotra, Kabir Malhotra, Anjali Malhotra, Aneesha Labroo, Nisheeta Labroo, Deepak Varde and Yuthica Mahindra Family Trust, by way of Second Leg of Transmission.
