# रोडवेज की जमीन पर वाहन खड़ा किया तो देना होगा शुल्क दुपहिए वाहन के 5 और फॉर व्हीलर के 10 रुपए शुल्क, पहले दिन ही आई शिकायत

राजस्थान राज्य पथ परिवहन निगम की जमीन पर अब वाहन खड़ा करने पर आपको शुल्क देना होगा। इसके लिए रोडवेज ने अस्थाई रूप से 5 हजार रुपए माह में पार्किंग का ठेका दिया है। ऐसे में अब आपको दो पहिए वाहन के 5 रुपए और फॉर व्हीलर वाहन के 10 रुपए देने होंगे। रोडवेज मुख्य प्रबंधक रवि मेहरा ने बताया कि यह ठेका अस्थाई महाने के हिसाब से दिया है। इससे पार्किंग व्यवस्था भी सही से हो पाएगी।

साथ ही लोगों को अव्यवस्था नहीं होगी और अपने वाहन की सुरक्षा भी होगी। लेकिन पार्किंग के शुरू होते ही लोगों की शिकायत भी आने लग गई कि सवारियों को छोड़ने आने वाले लोगों से जंवरदस्तों से शुल्क वसूली को जा रही है। हालांकि इस मामले में ठेकेदार कमल का कहना है कि किसी भी सवारी या उनके परिजनों केलाशंकर राव, एडवोकेट हरेंद्र पाठक, नितेश बैरागी अतिथि के रूप

नहीं किया गया। पूर्व में ही पार्किंग में लगा रखे कार्मिकों को भी विशेष निर्देश दिए हैं कि वो किसी भी से अवैध वसूली या दुर्व्यवहार ना करें। कई बार सवारियों को छोड़ने आने वाले लोग बीचो-बीच बाइक खड़ी कर जाते हैं। उनसे सिर्फ समझाइश की जाती है कि वो वाहन को बीच में खड़ा न करके, पार्किंग में करें। हालांकि इस मामले को लेकर प्रबंधक ने ठेकेदार को तुरंत बुलाकर निर्देश दिए कि अगली बार ऐसी को शिकायत नहीं आनी चाहिए।

Therefore, the company has approached PICUP for settling its dues to resolve the matter amicably in view of the stay granted by Hon'ble Arbitral Tribunal against PICUP application. The Company has filed application again for OTS as per offer received from PICUP which is under negotiation and also NCD holder liability for OTS.

3. The Company has abandoned its PTA project, as it has not been in operation since Sep 2002 due to various reasons beyond its control and has derecognized / corroded / depreciated as unused / uncompleted. Company is in the process of filing its petition against PICUP application. The Company has filed application again for OTS as per offer received from PICUP which is under negotiation and also NCD holder liability for OTS.

4. The Company has appointed one of the largest plant disposal & management consultant to auction the disposal of plant & equipments by scraping. During the quarter company has sold plant group of Rs. 137.54 Lacs, resulting in revenue from operation of Rs. 6.50 Lacs for the quarter December 2018.

5. The figures for the corresponding previous period have been restated/re-grouped wherever necessary, to make them comparable.
