Due to the impact of Covid-19 across the globe, the company was not able to operate at full extent to meet its minimum operating cost, leading to loss of income/Sale and negative cashflow in the first quarter of FY 2021. It had become very difficult for the company to operate and to manage even the minimum operational cost.

3. The Company has incurred losses of Rs. 1,69,53 lakhs (before other comprehensive income) for the quarter ended June 30, 2021 (quarter ended March 31, 2021 - Rs. 1,63,39 lakhs).

4. The Company has only one reportable segment - Garments.

5. For the quarter ended June 30, 2021, the application of Ind AS 115 has resulted in the Finance costs being higher by Rs.1081.65 lakhs (Quarter ended March 2021 - Rs. 1,007.66 lakhs) and loss after tax being higher by a similar amount vis-a-vis the amounts if the replaced standard was applicable.
