HC orders registration of case against MHADA officials

PRESS TRUST OF INDIA
Mumbai, September 18

THE BOMBAY HIGH Court on Wednesday directed the police to register a case against officials of Maharashtra Housing and Area Development Authority (MHADA) for allegedly colluding with developers and causing a loss of ₹40,000

crore to the state exchequer. A division bench of Justices SC Dharmadhikari and SK Shinde was hearing a public interest litigation filed by Kamalakar Shenoy, claiming that MHADA has failed to take possession of around 1.37 lakh square meters of surplus area from developers after redevelopment of cessed buildings.

MHADA, the government housing agency, also looks after maintenance of hundreds of old and dilapidated privately-owned building in Mumbai, whose tenants pay its 'cess'. The petitioner claimed that as per the Development Control Regulation 33 (7), any surplus area of a redevelopment project is the property of the state government.
