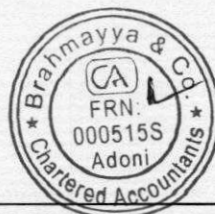



**Opinion**
