## Police should clear doubts about BTEch graduate's 'mysterious' death: Odisha LoP

**SAMBALPUR, MARCH 4/--** Leader of Opposition in Odisha Assembly Jayanaryan Mishra said questions have been raised about the mysterious death of a BTEch graduate in Burla and police should clear the doubts. The body of BTEch graduate of Veer Surendra Sai University of Technology (VSSUT), Burla, Chinmayee Priyadarshini Sahu was fished out from the power channel of Hirakud Dam on March 1. Speaking to media persons on Friday, Mishra alleged that police are trying to suppress the issue. Doubts have been raised in the death incident of the girl and police should try to clear the doubts, he said. The BJP leader said that if the police don't take appropriate steps, the issue would be raised in the Assembly. Chinmayee, who was from Madanpur Rampur in Kalahandi district allegedly jumped into the power channel of Hirakud Dam after receiving her degree in the convocation, which was held on February 28. Her family members, however, alleged that she was thrown into water. Sources in VIMSAR, where the autopsy was conducted, said, the autopsy report has already been handed over to the police and report found drowning to be the cause of death. Police said, prima facie, no evidence substantiating the allegation, made by the family, has been found. However, the investigation into the matter is still on and it is being investigated on the basis of the allegation. To investigate all possible angles of the case, police have also formed special teams.

Inspector-in-charge (IIC) of Burla police station, Susant Dash said, a team has been sent to Bhubaneswar. The team will search the rented room of Chinmayee in Bhubaneswar to find if there is any written document related to the incident. Moreover, a scientific team visited the spot, where the incident took place, on Friday. This apart, some friends of Chinmayee are also being interrogated, he said. (PTT)

## Jharkhand Assembly adjourned twice after ruckus over new employment policy

**RANCHI, MARCH 4/--** The Jharkhand Assembly was on Saturday adjourned twice after the BJP-led opposition members created a ruckus on the issue of the new employment policy. The opposition legislators and a ruling party MLA alleged that the draft of a new employment policy was passed in the state cabinet without taking the House into confidence. They demanded that the government should clarify it. A new employment policy had earlier been unanimously passed in the House but was scrapped by the High Court of Jharkhand last year. The treasury bench tried to pacify the opposition MLAs assuring them that it would give a reply on the issue on March 13 but BJP MLAs came to the well of the House in protest. The House was first adjourned till noon and then till 2 pm. After functioning of the House for about 40 minutes amid uproar in the second half, it was adjourned till March 13. At the beginning of the day's proceedings, senior JMM leader Lobin Hembrom said

that there is confusion in the state after the cabinet reportedly approved a new recruitment policy. "If the government passed any employment policy in the cabinet, it should be announced in the Assembly. If not, it should be considered as contempt of the House," he said. The Jharkhand Cabinet on Thursday approved amendments to various rules related to the Jharkhand Staff Selection Commission (JSSC) examinations, including doing away with a clause that disallowed candidates, with academic certificates from institutions outside the state, to appear in the test. The Cabinet also gave its nod to the amendments, which among other changes, added Hindi, English and Sanskrit to the list of languages for the JSSC examination, taking the total number of languages to 15. Echoing Hembrom, BJP MLA Neelkanth Singh Munda said, "A 1932 Khatiyani-based new employment policy had been passed unanimously in the House last year. Now, we came to know from the media that the government intends to implement a pre-2016 employment policy after the new policy was scrapped by the High Court."

## West Bengal: Congress leader Kaustav, arrested for comments on Mamata, gets bail

**KOLKATA, MARCH 4/--** West Bengal Congress spokesperson Kaustav Bagchi was granted bail by a court in Kolkata on Saturday evening, hours after being arrested for his alleged comments against Chief Minister Mamata Banerjee. A huge team of the Burtolla police station in North 24 Parganas district around 3.30 am, and arrested him after a few hours. Bagchi, also a lawyer, was granted bail on a personal bail bond of Rs 1,000 by the additional chief metropolitan magistrate at Banskhal court. The court directed him to meet the investigating officer once a week. The prosecution prayed for Bagchi's police custody till March 10 for questioning him, alleging he was involved in a conspiracy.

Praying for bail, Bagchi's lawyers questioned why a lawyer was arrested by the police early in the morning from his residence, instead of serving him a notice. The arrest was not necessary since the charges against him in the FIR do not entail a sentence of over seven years, his lawyers told the court. Bagchi was arrested on the basis of a complaint filed at the Burtolla police station on Friday night by one Sumit Singh, who claimed to be a TMC supporter, for his alleged comments against the chief minister. Bagchi allegedly criticised Banerjee for making "personal attacks" on state Congress president Adhir Ranjan Chowdhury after the party snatched the Sagardighi seat in Murshidabad district from the TMC in a bypoll. He was booked under several sections of the IPC, including 120-B (criminal conspiracy), 504 (intentional insult with intent to provoke breach of the peace) and 506 (criminal intimidation). The Congress workers protested against the arrest at various places across the state, including Baharampur and Kolkata. The BJP's legal department at the Calcutta High Court also condemned the arrest. (PTT)
