


**Limited Review Report**

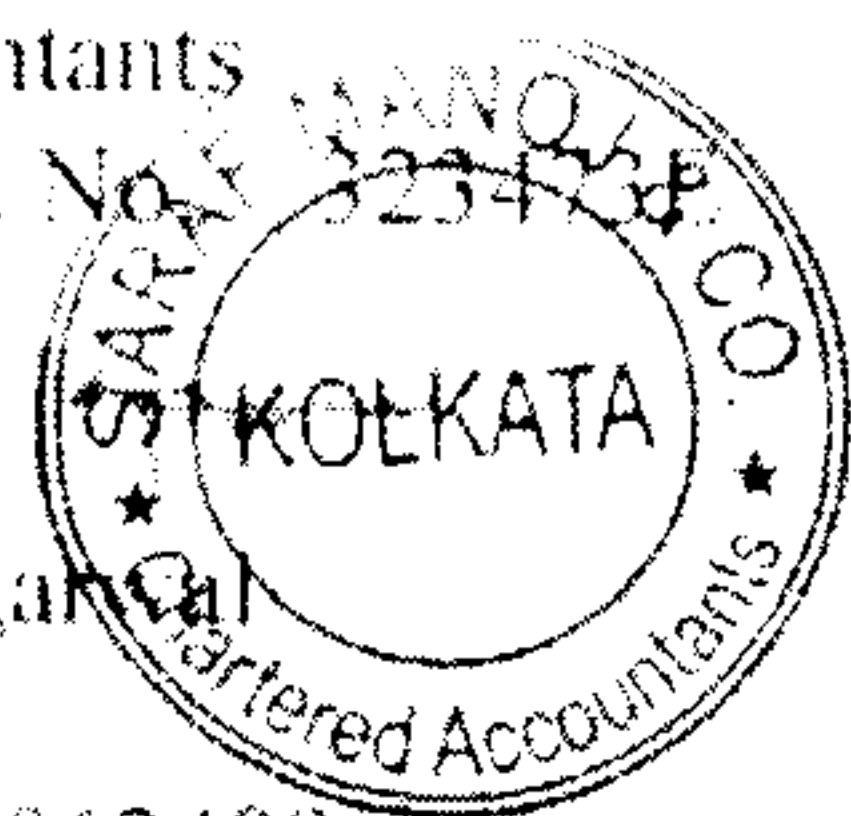
