P.; (3) The Project Administrator, and Superintending Engineer, Irrigation and C.A.D Department, T.T.P.R. Circle, Vizianagaram, A.P.; and (4) The Executive Engineer., T.B.P. Division No. 1, Parvatipuram, Vizianagaram District, A. P.
b. Court / Tribunal / Agency where Appeal is filed.	High Court of Andhra Pradesh, at Amaravati
c. Brief Details of dispute	Claims were filed by the Company before the Special Judge for Trial and Disposal of Commercial Disputes, Visakhapatnam (“the Court”), against the Opposite Parties arising out of works contract executed by the Company for the Opposite Parties at Andhra Pradesh. Vide the Court’s judgment dated September 20, 2024, the Company was awarded a portion of its claims amounting to a sum of Rs. 36.13 Crore along with interest and also costs thereon.  The Company, after seeking legal advice, decided to file an Appeal challenging the Court’s judgment, in respect of claims of Rs.14.70 Crore, before the Andhra Pradesh High Court, at Amaravati.
<b>Expected financial implications, if any.</b>	The financial impact, if any, can only be determined upon the disposal of the Appeal by the Hon’ble High Court of Andhra Pradesh, Amravati.
<b>Quantum of claims, if any</b>	Rs.14.70Crore.
