

Liz new UK PM



Britain's Conservative Party has chosen Foreign Secretary Liz Truss as the party's new leader, putting her in line to be confirmed as Prime Minister. Truss's selection was announced Monday in London after a leadership election in which only the 180,000 dues-paying members of the Conservative Party were allowed to vote. AP/PTI

UK foreign secretary Liz Truss defeated Indian-origin former chancellor Rishi Sunak to be named the winner of the Conservative Party leadership contest on Monday and will now go on to formally take charge as British Prime Minister as Boris Johnson's successor.

The 47-year-old senior Cabinet minister was widely expected to become the third female British Prime Minister after over 170,000 online and postal votes cast by Tory members, ending Sunak's historic run as the first member of Parliament of Indian heritage to compete for the top job at 10 Downing Street.

Truss polled 81,326 votes, compared to Sunak's 60,399 in an election with a high turnout of 82.6 per cent, with 654 rejected ballots from a total of 172,437 eligible Tory voters. It means Truss won by a comfortable margin, but her victory was slimmer than in other recent Tory leadership contests at 5.4 per cent to Sunak's 42.6 per cent — reflecting a divide within the

governing party.

Sunak, 42, soon took to Twitter to call for party unity: "Thank you to everyone who voted for me in this campaign. I've said throughout that the Conservatives are one family."

"It's right we now unite behind the new PM, Liz Truss, as she steers the country through difficult times."

In her acceptance speech, Truss declared: "We will deliver, we will deliver, and we will deliver."

"I will deliver on the energy crisis, dealing with people's energy bills but also dealing with the long-term issues we have on energy supply," she said, with reference to the key issue dominating the leadership campaign which she dubbed "one of the longest job interviews in history".

After thanking her fellow finalist Sunak, Truss also paid tribute to outgoing leader Johnson.

"Boris, you got Brexit done, you crushed [Opposition Labour ex-leader] Jeremy Corbyn, you rolled out the vaccine and you stood up to Vladimir Putin. You are admired

from Kyiv to Carlisle," she said, to a rather muted response from her party colleagues gathered for the announcement.

And, her reference to a Tory victory under her leadership in 2024 will be seen as a sign of ruling out the prospect of an early general election.

The result was formally announced by the returning officer of the leadership contest and chair of the Conservative Party's powerful 1922 Committee of backbench MPs, Sir Graham Brady, at the Queen Elizabeth II Centre near Downing Street in London.

However, for pollsters, political analysts and media outlets it came as little surprise as Truss had been the frontrunner to beat 42-year-old Sunak in pre-poll surveys and bookmaker odds on the race.

A combination of the Tory membership base's lingering loyalty towards outgoing Prime Minister Boris Johnson, whom they see as being betrayed by former close ally Sunak, and Truss's pledge to cut taxes are among the key factors behind the British Indian MP failing to clinch the

China locks down 6.5 cr

Discourages holiday travel following outbreak of Covid in 33 cities, including 7 provincial capitals

China has locked down 65 million of its citizens under tough Covid-19 restrictions and is discouraging domestic travel during upcoming national holidays.

Across the country, 33 cities including seven provincial capitals are under full or partial lockdown covering more than 65 million people, according to a tally published late Sunday by the Chinese business magazine Caixin.

It said that outbreaks have been reported in 103 cities, the highest since the early days of the pandemic in early 2020.

Despite a relatively low number of infections, authorities have adhered to a "zero-COVID" policy requiring lock-



city of Tianjin, classes have been moved online after 14 new cases were reported, all but two showing no symptoms.

Chengdu lifted the lockdown for about 1 million people in Qionglai city and Xinjin district, two areas in its southwest. Three more rounds of mass testing are being held through Wednesday. And schools remain closed with all classes online.

Sept. 10-12 is China's mid-autumn festival, the country's second-most important holiday after the Lunar New Year. The anti-virus measures have taken a major toll on the economy, travel and society in general, but China's ruling Communist Party says they are necessary to prevent a wider spread of the virus, first detected in the cen-

tral Chinese city of Wuhan in late 2019.

The fear of being caught in a lockdown or sent to a quarantine facility for even being in proximity with a person who tested positive has severely constrained people's work, socializing and travel habits.

Since the outbreak began, China has placed tens of millions of people under lockdowns that have been strictly enforced, sometimes preventing residents from obtaining food, health care and basic necessities.

A more than five-week closure of Shanghai, China's largest city and key financial hub, in the spring upended the local economy, prompted protests and led to an exodus of foreign residents.

Biden visiting 2 swing States as midterm crunch time begins

US President Joe Biden is making his third trip to Pennsylvania in less than a week and returning just two days after his predecessor, Donald Trump, staged his own rally there — illustrating the battleground state's importance to both parties as Labour Day kicks off a nine-week sprint to crucial midterm elections.

Trump spoke Saturday night in Wilkes-Barre, near Scranton, where Biden was born. The president made his own Wilkes-Barre trip last week to discuss increasing funding for police, decry GOP criticism of the FBI after the raid on Trump's Florida estate and to argue that new, bipartisan gun safety measures can help reduce violent crime.

Two days after that, Biden went to Independence Hall in Philadelphia for a prime-time address denouncing the "extremism" of Trump's fiercest supporters.

On Monday, he's attending Labour Day festivities in Milwaukee, in another key swing state, Wisconsin, before traveling to Pittsburgh for that



city's parade.

The White House says Biden will celebrate "the dignity of American workers". The unofficial start of fall, Labour Day also traditionally kicks off political crunch time, with campaigns scrambling to excite voters ahead of Election Day on November 8.

That's when control of the House and Senate, as well as some of the country's top governorships, will be decided.

Trump has endorsed candidates in key races around the country and Biden is warning that some Republicans now believe so strongly in Trumpism that they are willing to undermine core American values to promote it.

US B-52 bombers fly over West Asia amid tensions with Iran

The United States military said Monday it flew a pair of nuclear-capable B-52 long-distance bombers over the Middle East in a show of force, the latest such mission in the region as tensions remain high between Washington and Tehran.

The bombers took off from the Royal Air Force base at Fairford, England, and flew over the eastern Mediterranean, the Arabian Peninsula and the Red Sea on Sunday in training missions together with Kuwaiti and Saudi warplanes, before departing the region.

"Threats to the U.S. and our partners will not go unanswered," Lt. Gen. Alexus Grynke, the top U.S. Air Force officer in the Middle East said in a statement. "Missions like this ... Showcase our ability



to combine forces to deter and, if necessary, defeat our adversaries."

Although the U.S. Military's Central Command did not mention Iran, Washington has frequently dispatched B-52 bombers to the region as hostilities simmered between the U.S. and Iran. The last such flyover was in June.

Iran's regional foe, Israel, also joined in the multinational mission. Though unacknowledged by the U.S., three Israeli F-16 fighter jets accompanied the American bombers "through Israel's skies on their way to the (Persian) Gulf," the Israeli military said, describing the country's cooperation with the U.S. Military as key to "maintaining aerial security in Israel and the Middle East."

Lanka to oppose new rights resolution at UNHRC

Sri Lanka will oppose a new resolution on its human rights accountability, especially an external investigation mechanism, at the UN Human Rights Council session getting underway this week, Foreign Minister Ali Sabry said here on Monday.

Sabry told reporters that Sri Lanka was not agreeable to an external mechanism to investigate human rights abuses as it would be a violation of the country's Constitution.

Sabry, commenting upon the 51st sessions of the UN human rights council to be held from September 12 to October 7 in Geneva, said the Minister of Justice Wijeyedasa Rajapakse would represent the government at the sessions.

"We will oppose the human rights commission investigation mechanism as it is against our Constitution," he told

Germany, Israel mark 50th anniv of 1972 Olympic attack

The German and Israeli presidents are to join relatives of the 11 Israeli athletes killed in the attack by Palestinian militants on the 1972 Munich Olympics to mark the 50th anniversary on Monday, days after an agreement that ended a long dispute over compensation.

Monday's ceremony takes place at the Fuerstenfeldbruck airfield outside Munich, the scene of a botched rescue attempt in which nine of the Israeli athletes, a West German police officer and five of the assailants were killed.

Last week's agreement headed off a threatened boycott of the anniversary event by relatives of the slain athletes. They will receive a total of 28 million euros (dollars) in compensation, a significant increase from the initial 10 million-euro offer.

As part of the agreement, Germany has agreed to acknowledge failures by authorities at the time and to allow German and Israeli historians to review the events surrounding the attack.

Measles outbreak has killed 700 children, says Zimbabwe

The death toll from a measles outbreak in Zimbabwe has risen to almost 700 children, the country's health ministry has said. Some are calling for the enactment of legislation to make vaccination mandatory in a country where anti-modern medicine religious sects hold sway on large swathes of the population of 15 million people.

The southern African country's health ministry announced at the weekend that 698 children have died from measles since the outbreak started in April.

The ministry said 37 of the



deaths occurred on a single day on September 1. The health ministry said it had recorded 6,291 cases by September 4.

The latest figures are more than four-times the number of deaths announced about two weeks ago when the ministry said 157 children, most of whom were unvaccinated due

to their family's religious beliefs, had succumbed to the disease.

Dr. Johannes Marisa, the president of the Medical and Dental Private Practitioners of Zimbabwe Association, told The Associated Press on Monday that the government should escalate an ongoing mass vaccination campaign and embark on awareness programs targeted especially at anti-vaccine religious groups.

"Because of the resistance, education may not be enough so the government should also consider using coercive measures to ensure that no one is allowed to refuse vaccination for their children," said Marisa.
