We have reviewed the accompanying statement of Unaudited Financial Results of **BENGAL STEEL INDUSTRIES LIMITED** (the "Company") for the quarter ended 30<sup>th</sup> June, 2020 ("the statement") being submitted by the Company pursuant to the requirements of Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("Listing regulations").   - c. Book balance of Rs. 18,506.21 with UCO bank, Rs. 30,471.80 with HDFC Bank, Rs. 1,45,762.45 with UBI and Rs. 59,939.19 with Bank of India could not be confirmed.
  - d. Non recognition of Impairment loss.
