Rafale: Rahul Gandhi draws SC flak for not admitting mistake over his remarks

PRESS TRUST OF INDIA New Delhi, April 30

CONGRESS **PRESIDENT RAHUL** Gandhi on Tuesday drew flak from the Supreme Court over his fresh affidavit in which he did not directly admit his mistake for incorrectly attributing the allegedly contemptuous "chowkidar chor hai" remark to the apex court in the Rafale verdict.

"When you commit mistake, you should admit the mistake," said a bench headed

by Chief Justice Ranjan Gogoi. It pointed out that at one point, Gandhi is admitting the mistake and at another denying having made the contemptuous remarks. "We have great difficulty in understanding what you want to say in the affidavit," said the bench, also comprising justices SK Kaul and KM Joseph.

The bench, which gave another opportunity to Gandhi to file a better affidavit relating to his remark, said, "You make the statement and then justify it."

Listing of Azhar as global terrorist by UN will be 'properly resolved': China

PRESS TRUST OF INDIA Beijing, April 30

CHINA SAID ON Tuesday that "some progress" has been achieved on designating Jaish-e-Mohammed chief Masood Azhar as a global terrorist by the UN and hoped that the vexed issue will be "properly resolved" but refused to give any timeline.

The comments by the Chinese foreign ministry spokesman on Tuesday came days after President Xi Jinping met Pakistan Prime Minister Imran Khan here.

China put a technical hold in March on a fresh proposal to impose a ban on the head of Pakistan-based JeM which claimed responsibility for the deadly Pulwama terror attack. It was for the fourth time, China blocked Azhar's listing as a global terrorist by the UN.

"Regarding the listing issue in the 1267 Committee, we have expressed our position many times and I just want to stress two points," foreign ministry spokesman Geng Shuang said answering a number of questions on designating Azhar as a global terrorist under the 1267 Al Qaeda Sanctions Committee of the UN Security Council. "First, we support the listing issue being settled within the 1267 committee through dialogue and consultation and I believe this is the consensus of most members. Second, the relevant consultations are going on within the committee and has achieved some

progress,"he said at a media briefing here.
