
We have not received the sub-divided equity shares of F.V. Rs.2/- since they may have been posted to our old address.

Please let us know the procedure for issuing duplicate certificates and oblige.

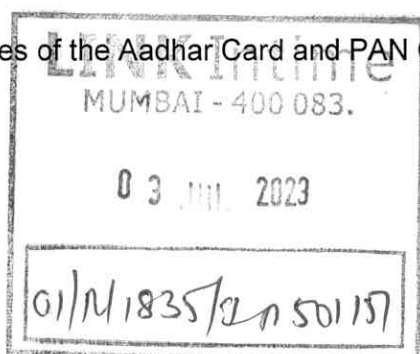
