While H1 sales were hit by pandemic, most categories saw strong recovery in July-Dec

NEW DELHI Mumbai: Covid-19 led to a sharp decline in consumer spending on big-ticket categories such as televisions, appliances, smartphones and cars. However, the overall market showed a strong recovery in July-Dec. The market was hit by the pandemic in the first half of 2020. As many as 10 lakh cars and SUVs were sold between October and December, the highest on record for a six-month period, compared with a 4% volume decline in the first half of 2020.

Global automotive performance firm IHS Markit has revised its outlook on car production in India from a 3% fall in 2020 to a 2% decline by the end of the year as a result of the strong second half bounce back, executive director Ashish Vaidya said.

Shankar Srinivasan, associate director - sales and marketing at India's largest car maker Maruti Suzuki, said 2020 was a "year of two halves" - a disastrous first six months from the sales point of view and a strong second half. The industry ended with negative volume, the strong recovery in the second half surprised many, especially the October and December quarters. The volume decline in 2020 is much lower than initially anticipated, said Vaidya.

Smartphone maker Realme India's chief executive, Madhav Sethi, said its smartphone sales grew 2% in the second half of 2020.

"Consumers are now inclined more towards 5G-enabled mid-range smartphones... Factory production has also scaled up to 90% normal as workers have returned to the factory and we are trying to meet the demand for smartphones."

India's largest appliance maker, LG India, posted 3% growth in the second half of 2020 and 1% in 2020, against its initial forecast of a 1% drop. In 2019, some 152 million smartphones were sold in India, the IDC India research director, Naveen Kumar, said. The best performer among smartphones, with September leading the highest ever month followed by October.

"Expenditure and sales of entry-level smartphones are showing a strong prelude before ₹7,000 smartphones, which have driven sales," he said.

DoT to Discuss 5G Road Map with Telcos, Vendors, Tech Cos Tomorrow

Kolkata: The Department of Telecommunications (DoT) will meet stakeholders, including telcos, global tech vendors such as Google, Facebook and Apple, and network vendors on Wednesday to discuss a comprehensive road map for spectrum allocation over the next few months. The meeting is expected to be held for high speed 5G services.

A virtual meeting will be chaired by the telecom secretary to discuss possible sharing of spectrum under spectrum allocations, frequency bands (that should be considered for 5G) and other uses and roadmap for speed radio-frequency spectrum in India during the next 10 years. 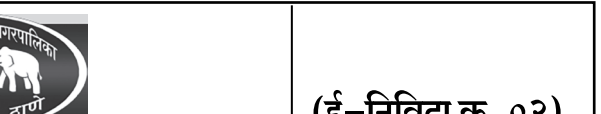
