Dear Sir,

We write in reference to the said Article referenced hereinabove. The said Article (attached for your reference) states that the enforcement directorate unearthed a series of transactions whereby several shell companies had deposited large amounts of money with the firm Capstone Forex, being currently under investigation by said agency. The said Article further states that some of the shell companies had also dealt with reputed companies such as “....., ***Jain Energy (Jain Irrigation Group)***, .....etc.”.

We would like to bring to the attention of the recipient stock exchanges that the company ‘***Jain Energy***’ referenced in the said Article as “***Jain Group Company***”, has neither being part of Jain Irrigation Group nor it is associated, affiliated or (directly or indirectly), owned, control or under common control of JISL or any of its group companies, promoters or directors in any manner whatsoever.

Such reference in the article is blatantly untrue, incorrect, misleading and JISL is in process of taking immediate steps to approach MoneyControl.com to rectify the mistake and seek a clarification/apology and also take appropriate legal measures, if required
