Sub: Request for Grant of time for Submission of Financial Results for the year ended 30<sup>th</sup> June 2021.

We write this to your good office to humbly seek extension of time till 15<sup>th</sup> September 2021 for submission of the aforesaid financial result for the first quarter ended 30<sup>th</sup> June 2021 considering the situation of prolonged restrictions in the State due to the outbreak of novel coronavirus (COVID-19). Considering the recent situation of nationwide lockdown by Central Government and also by State Government in West Bengal, where the registered office, corporate office of the Company is situated, due to sudden outbreak of COVID-19 pandemic, it will be challenging for the Company to prepare financial statements of the Company in accordance with Regulation 33 of the Listing Regulations for the quarter ended 30th June 2021 and publish the same within the prescribed time period. Thus, for reasons set out in this letter, the Company requires an extension of time for filing of the financial results of the Company for the quarter ended 30th June, 2021.

We wish to inform you that the preparation of the Results has not been completed despite the Company taking adequate steps within its control as a result of restrictions imposed by the Government on opening of private offices and on travelling of non-essential service staff due to Covid Pandemic (2nd Wave), our staff as well as the statutory auditors along with their audit staff are able to attend the work places alternatively. Hence, we are trying our level best complete the books of accounts of June 2021 within the stipulated time. But we are in the process of finalization and closing the fourth quarter and year ended books of accounts that why we are unable to submit our first quarter financial results ended June 30, 2021 on or before the stipulated date i.e., 14th August, 2021.

In the view of above and also considering the fact that not only the operation of the company but entire economy of the country having been impacted by the force majeure condition (Covid-19), In the light of above circumstances, we request your good self to kindly grant us

extension of time for submission of unaudited financial results for the first quarter ended 30<sup>th</sup> June 2021 up to 15<sup>th</sup> September 2021.

Hence, under the situation explained above, we sincerely bring to your kind attention that our June quarter financial results are getting delayed beyond August 14, 2021, though the Company is trying its level best to do the same as early as possible.

In view of the such extra-ordinary circumstances as mentioned above, we request you to take lenient view in the above matter.
