CAREER POINT RECEIVES APPROVAL FOR ITS BID FOR IL&FS EDUCATION ASSETS

Career Point Ltd (NSE: CAREERP; BSE: 533260), nation's leading education player and training player has been informed that Career Point's bid through its' associate company Career Point Publication Private Limited (CPPPL) for Infrastructure Leasing and Financing Services Limited (IL&FS) group's education business is approved by the Committee of Creditors (CoC) of IL&FS Ltd.

Under this bid, Career Point has proposed to acquire the majority stake of IL&FS group in Schoolnet India Limited - SIL (erstwhile IL&FS Education & Technology Services Limited - IETS) and 80% ownership in IL&FS Skill Development Corporation (ISDC) held by SIL. The Board of IL&FS Ltd. approved the sale in its meeting held on 7 November, 2019. The transaction will now be subject to the approval of the Hon. National Company Law Tribunal (NCLT), Mumbai Bench, in line with the Resolution Framework.
