

- The Company undertook various R&D initiates and associations to develop, scale up new technologies and also improve upon existing technologies and products.
- The Company's Product Division achieved Commercialising the Sanjeevak carbonisation systems for treating biomass waste and launch of GAC-01, making its entry into the activated carbon market. On one hand sale of Sanjeevak carbonization systems will increase the product pipeline and the resulting production of activated carbon and subsequent sale agreements will provide additional revenue streams.
- In addition our Consulting Division has begun commercial operation with orders to execute detail feasibility report for PSU's and Project developers for developing and establishment of waste to compressed biogas projects.
