# एसटी कर्मचाऱ्यांना वेतनाची प्रतीक्षा

## मे महिन्याचे वेतन आर्थिक अडचणींमुळे रखडले

मंबई, दि. ८ : एसटी कर्मचाऱ्यांना मे महिन्याचे वेतन आर्थिक अडचणींमुळे एसटी प्रशासन देऊ शकलेले नाही. त्यामुळे भविष्यात येणाऱ्या आर्थिक अडचणींचा सामना करण्यासाठी शासनाने एसटी कर्मचाऱ्यांच्या वेतनासाठी पुढील सहा महिन्यासाठी निधी उपलब्ध करून द्यावा, अशी मागणी महाराष्ट्र एस टी कर्मचारी काँग्रेसचे सरचिटणीस श्रीरंग बरगे यांनी परिवहन राज्यमंत्री सतेज ऊर्फ बंटी पाटील यांच्याकडे प्रत्यक्ष भेट्रन निवेदना द्वारे केली आहे.

महामंडळातील कर्मचाऱ्यांना प्रत्येक महिन्याच्या ७ तारखेला वेतन अदा केले जाते. मात्र मे महिन्याचे वेतन ७ जून रोजी कर्मचाऱ्यांना अदा करण्यात आलेले नाही. त्यामुळे कर्मचाऱ्यांमध्ये प्रचंड असंतोष पसरला आहे.एक तर एसटी कर्मचाऱ्यांना इतरांच्या तुलनेत खूपच कमी पगार आहेत. त्यामुळे त्यांच्या संसाराचा गाडा चालवण्यासाठी जर ठरलेल्या तारखेला पगार मिळाले नाही, तर त्यांना अनेक अडचणी निर्माण होतात.

करोना प्रादुर्भावामुळे एसटी वाहतूक बंद असल्याने गेली सव्वा वर्ष महामंडळाला प्रवासी उत्पन्न मिळत नाही. महामंडळ आर्थिक संकटात सापडले असून एसटी कर्मचाऱ्यांना वेतन देण्यासाठी महामंडळाकडे निधी उपलब्ध नाही. तसेच, त्यामध्ये अजून काही महिने फार मोठा फरक पडेल अशी परिस्थिती नाही. तरी एसटी वाहतूक पूर्ववत चालू होईपर्यंत कर्मचाऱ्यांच्या वेतनासाठी शासनाने एसटी महामंडळात अर्थसहाय्य करावे यासाठी सर्व संबंधित मंत्री



## शिथिलतेत कोव्हीड सुरक्षा नियमांचे पालन करा

### नवी मुंबई महानगरपालिका आयुक्तांचे आवाहन

वाशी, दि. ८ : दैनंदिन कोरोनाबाधीतांची संख्या मागील आठवड्याभरापासून शंभराच्या खाली स्थिरावलेली दिसत असताना स्थानिक आरोग्य स्थितीचा विचार करून नवी मंबई महानगरपालिका क्षेत्रात शासन निर्देशानुसार स्तर २ करिताचे निर्बंध जाहीर करण्यात आले आहेत. या निर्बंधांचे काटेकोर पालन होईल याकडे बारकाईने लक्ष देण्याचे निर्देश देत महापालिका आयुक्त श्री. अभिजीत बांगर यांनी कोव्हीडच्या संभाव्य तिस-या लाटेला सामोरे जाण्यासाठी करण्यात येत असलेल्या कामांचा विषयनिहाय आढावा घेतला. या बैठकीस प्रशासन विभागाचे उपआयुक्त श्री. दादासाहेब चाबुकस्वार, शहर अभियंता संजय देसाई, उपआयुक्त डॉ. बाबासाहेब राजळे, योगेश कडुस्कर, वैद्यकीय आरोग्य अधिकारी डॉ. धनवंती घाडगे, परिवहन व्यवस्थापक शिरीष आरदवाड व परिवहनचे मुख्य लेखा व वित्त अधिकारी निलेश नलावडे उपस्थित होते.'ब्रेक द चेन' करिता निर्बंधांचे ५ स्तर शासनामार्फत जाहीर करण्यात आले असून त्यामध्ये नवी मुंबई महानगरपालिका दुस-या स्तरात आहे. त्याबाबतचे नवी मुंबई महानगरपालिका स्तरावरील आदेश निर्गमित करण्यात आले

परिस्थितीनुसार शिथील करण्यात आले आहेत, त्यामुळे कोव्हीड प्रतिबंधासाठी अधिक सतर्कतेने काम करण्याची गरज आयक्तांनी यावेळी व्यक्त केली. कोणत्याही परिस्थितीत सार्वजनिक ठिकाणी गर्दी होणार नाही व मास्क, स्रक्षित अंतर अशा कोरोना प्रतिबंधात्मक स्रक्षा नियमांचे काटेकोर पालन केले जाईल याकडे विशेष लक्ष देण्याचे निर्देश आयुक्तांनी दिले. यादृष्टीने विभाग पातळीवरील दक्षता पथके तसेच मुख्यालय स्तरावरील विशेष दक्षता पथके यांनी कोव्हीड नियमांचे उल्लंघन होणार नाही याकरिता अधिक कटाक्षाने लक्ष ठेवण्याचे आदेशित करण्यात आले.

आपल्याकडील पहिल्या व दुस-या लाटेच्या प्रभावाचा तसेच इतर देशांमधील तिस-या लाटेच्या प्रभावाचा अभ्यास करता संभाव्य तिस-या लाटेची पूर्वतयारी करण्याच्या दृष्टीने आरोग्य सुविधांमध्ये वाढ करण्यात येत असून त्याचा सुविधानिहाय आढावा यावेळी घेण्यात आला. त्याचप्रमाणे आवश्यक असलेली वैद्यकीय उपकरणे तसेच औषध पुरवठा यांच्याही निविदा प्रक्रिया विहीत वेळेत पूर्ण कराव्यात असे आयुक्तांनी आदेशित केले.दुस-या लाटेमध्ये ऑक्सिजनची मोठ्या प्रमाणावर कमतरता भासली होती हे लक्षात घेत महानगरपालिकेच्या वतीने ४ ठिकाणी पोर्टेबल ऑक्सिजन प्लांट उभारण्यात येत असून या कामाला गती द्यावी व विहित कालावधीत काम पूर्ण करावे असे निर्देश आयुक्तांमार्फत देण्यात आले. खाजगी रुग्णालयांनीही त्यांना आवश्यक असलेला ऑक्सिजनची पूर्तता करण्याच्या दृष्टीने तत्पर कार्यवाही करण्याबाबत सातत्याने पाठपरावा करावा अशा सूचना आयुक्तांनी केल्या. प्रत्येक विभागात पुरेशा बेड्स क्षमतेची कोव्हीड केअर सेंटर असावीत यादुष्टीने नियोजन करून पृढील बैठकीत तपशील सादर करण्याच्या सूचना अभियांत्रिकी विभागाला देण्यात आल्या. कोव्हीडच्या दुस-या लाटेत आयसीयू बेड्स व व्हेन्टीलेटर्सची गरज मोठ्या प्रमाणात जाणवली होती. त्यामुळे महानगरपालिकेने कोव्हीड केद्रांकरिता तात्पुरत्या स्वरुपात भरती केलेल्या डॉक्टर्स, नर्सेस यांना आयसीयू कक्षात वैद्यकीय उपचार करण्याबाबत प्रशिक्षण दिले जात असून त्यांची क्षमतावृध्दी करण्यात येत आहे. यामध्ये कोव्हीडच्या तिस-या लाटेत कोरोना बाधीतांमध्ये मुलांचे प्रमाण अधिक असणार आहे अशी शक्यता वर्तविली जात असून त्यादृष्टीने पिडीयाट्रीक आयसीयू कक्षामधील वैद्यकीय उपचारांबाबतही विशेष प्रशिक्षण देण्याविषयी तत्परतेने कार्यवाही करावी असे सूचित करीत आयुक्तांनी या डॉक्टर, नर्सेस प्रशिक्षणातील समन्वयासाठी नोडल अधिकारी नियुक्त करावा असेही निर्देश दिले.

## पावसामुळे भाजीपाला खराब

नवी मुंबई, दि. ८ : दोन दिवसांपासून राज्यात तुरळक पावसाच्या सरी बरसत आहेत. त्यामुळे एपीएमसी भाजीपाला बाजारात भाज्यांची आवक कमी झाली आहे. त्यात बाजारात येणारा २० ते ३० टक्के शेतमाल खराब होत आहे.मुंबई कृषी उत्पन्न बाजार समितीत आवक होणारा भाजीपाला खराब होत आहे. विशेषतः पालेभाज्या लवकर नाशिवंत होत आहेत. त्यात राज्यातून होणारी आवकही कमी होत आहे. पावसामुळे ग्राहक कमी असल्याचा दरावर परिणाम झालेला दिसत नाही. भाज्यांचे दर स्थिर आहेत. एपीएमसी बाजारातील सुमारे ८० ते ९० भाजीपाला हा मुंबई उपनगरात विक्रीसाठी जात असतो.
