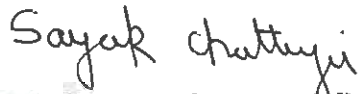

Auction of 11 mineral blocks put on hold

Among the blocks put on hold, two are gold mines, five limestone, three basemetal and one bauxite block

THE GOVERNMENT HAS put on hold the auction of 11 mineral blocks, including two gold mines, besides keeping in abeyance sale of four blocks.

The blocks on hold for auction are in Madhya Pradesh, while the mines kept in abeyance are in Jharkhand, according to a document of the mines ministry.

However, the mines ministry did not specify the rea-



sons for putting the sale of blocks on hold and in abeyance.

Among the blocks put on hold for auction, two are gold mines, five limestone, three basemetal and one bauxite block, the document said.

Of the mines kept in abeyance, two are bauxite blocks and one each of limestone and dolomite.

The notice inviting tenders of all 15 blocks was issued in

January 2020.

One mineral block was auctioned last month, while four more mines were put on sale this month. All the five blocks in Gujarat and Karnataka have reserves of 667.2 million tonne.

The Centre has recently asked states having mineral resources to identify at least five new mining projects for auction with pre-embedded clearance on a pilot basis, with a view to expediting the sale process as well as operationalisation of the blocks.

The mines ministry had recently released guidelines for the auction of mineral blocks with pre-embedded clearances as it explored ways to address the key issue of delay in mining production due to lack of various approvals such as forest and environment permissions.

The identified blocks would

be auctioned along with other blocks without pre-embedded clearances.

Under the guidelines, the Centre has asked states to set up a project monitoring unit (PMU) to complete the preparatory work for obtaining requisite clearances, approvals and related work. The unit would obtain all the clearances for starting a mining project.

Finance minister Nirmala Sitharaman had earlier announced various structural reforms in the mining sector as part of the over ₹20 lakh crore stimulus package to boost growth and job creation.

She had announced auction of 500 blocks and introduction of a seamless composite exploration-cum-mining-cum-production regime. So far, 97 mining leases have been allocated through auctions since 2015,

Trair notifies new interconnection rules for fixed line networks

New Delhi, July 10

TELECOM REGULATORY TRAI on Friday notified certain changes to the telecom interconnection rules, paving the way for easier interconnectivity between any two fixed line networks and between fixed line and national long distance (NLD) networks.

An industry observer said that Trai's "Telecommunication Interconnection (Second Amendment) Regulations 2020" will bring procedural clarity and convenience for fixed line operators, and also address areas like closure of interconnect points in event of service discontinuation within a short-distance charging area. Outlining the amendments, Trai said that within a service area, the location of points of interconnect for call between any two fixed line networks and fixed line and NLD networks will be at a place that is mutually agreed to between the interconnection provider and seeker.

The term 'interconnection' refers to commercial and technical arrangements under which telecom service providers connect their equipment, networks, and services to enable their customers to have access to subscribers of other operators' network.

If the two sides fail to come to an agreement, the location of point of interconnect (PoI) for such networks will be Long Distance Charging Centre (LDCC), the Telecom Regulatory Authority of India (Trai) said in a statement.

- Figures for the 4th quarter of Current Financial Year are the balancing figures between audited figures in respect of the full current Financial Year and the published year to date figures upto the 3rd quarter of the current Financial Year.
- The Board of Directors of the Company have proposed final dividend of Rs. 2.50 per share (face value of Rs. 10.00 per share) and further, Company has paid interim dividend of Rs. 10.00 per share (face value of Rs. 10.00 per share) for financial year 2019-20.
- Nationwide lockdown, consequent to spread of Covid-19 pandemic had temporarily disrupted the operations of the Company. The manufacturing facilities and other services during the period March 23rd to March 31st, 2020 were inoperative, which alongwith the COVID impact globally (before the lockdown in India) impacted the revenues for the year. Based on the internal & external information upto the date of approval of the financial statements, the Company expects to recover the carrying amount of its assets, investments, trade receivable, contract assets & inventories. The Company will continue to monitor the future economic conditions and assess its impact on its financial statements.

FACT imports 55k tonne of fertilizers so far in FY21

STATE-OWNED FERTILISERS and Chemicals Travancore (FACT) has imported 55,000 tonne of fertilizers so far this financial year.

"FACT has placed purchase orders for import of three ship-

ments of fertilizers. Out of this, two shipments have already arrived. In this, one shipment is of 27,500 tonne of MOP and the other one is of 27,500 tonne of complex fertilizer," an official statement said.

The third shipment is of MOP (Muriate of Potash) which is expected to arrive in August, it added.

The company is planning to restart Caprolactam operations during the current finan-

cial year, after completing major maintenance activities and installing online effluent monitoring facilities. Trial run of the plants has been completed, the statement said.
