30% peanut crop damaged in Gujarat due to rains

EXTENDED AND EXCESSIVE rains in groundnut sowing areas of Gujarat has damaged the peanut crop in the range of 15 to per cent and as a result of it, total crop would be around 34 to 38 lakh tonne against the state government's

first estimate of 55 lakh tonne.

Last year against the first es-

timate of 45 lakh tonne, groundnut production in Gujarat remained around 32 lakh tonne. Highest damage in the groundnut crop has been incurred in Junagadh district according to Kishor Viradia, president of Saurashtra Oil Mills Association (SOMA) adding that compared

to Saurashtra region, there has been lesser damage in North Gujarat area.

Compared to previous year's 16.29 lakh hectares groundnut sowing, current kharif sowing in the state has gone up to 20.72 lakh tonne. Last year per hectare productivity was 2764 kg per hectare. However, as per state government productivity would be lower this year to around 2740 kg per hectare.

As farmers got healthy rates for their groundnut crop during the 2019-20 season, many cotton growers switched to peanuts which resulted in an increase in sowing by almost 20 per cent this year. Despite expectation of bumper crop, groundnut growers would get better rates during

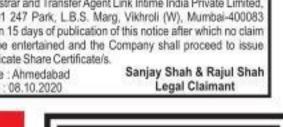
