## Sub: Intimation under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (SEBI Listing Regulations, 2015)-Change in Auditors

Pursuant to Regulation 30 of SEBI (Listing Regulations), 2015 read with SEBI Circular No. CIR/CFD/CMD1/114/2019 dated October 18, 2019, we wish to inform that based on the recommendation of the Audit Committee, the Board of Directors of the Company at its meeting held on 27<sup>th</sup> June, 2023 noted and accepted the resignation of M/s KARMA & Co. LLP, Chartered Accountants (ICAI Firm Registration No. 127544W/W100376) who have tendered their resignation vide their letter dated 26th June, 2023 informing their inability to continue as the Statutory Auditors of the Company.

The Audit Committee at its meeting held on 27<sup>th</sup> June, 2023 considered the item w.r.t. resignation of M/s KARMA & Co. LLP, Chartered Accountants as Statutory Auditors of the Company.

Based on the discussion between the members of the Audit Committee, the members are aligned with the reasons stated in the resignation letter received from the Auditors. The Audit Committee also noted that the Statutory Auditors have not raised any concern or issue.

The Board of Directors at its meeting held on 27<sup>th</sup> June, 2023 also noted that there are no other reasons other than mentioned in the resignation letter received from the Auditors dated 26th June, 2023 duly disseminated to exchange on receipt of the same.

The Audit Committee and Board at their respective meetings placed on record their appreciation to M/s KARMA & Co. LLP, Chartered Accountants for their contribution to the Company with their audit processes and standards of auditing.

Further, the Board of Directors at their meeting held on 27<sup>th</sup> June, 2023, on the recommendation of the Audit Committee and subject to approval of shareholders, has approved the appointment of M/s. MSKA & Associates, Chartered Accountants (ICAI Firm Registration No. FRN: 105047W) as Statutory Auditors of the Company to fill the casual vacancy caused due to the resignation of M/s. KARMA & Co. LLP, Chartered Accountants, as Statutory Auditors of the Company. The said appointment is pursuant to applicable provisions of the Companies Act 2013 and the SEBI Listing Regulations, 2015.
