- We have reviewed the accompanying Statement of Unaudited Financial Results of S.I. CAPITAL & FINANCIAL SERVICES LIMITED ("the Company") for the quarter ended 30th June, 2021 attached herewith, being submitted by the Company pursuant to the requirement of Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015 ("the Regulation") as amended.
- 2. - In compliance with the Regulation 33 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, a limited review of unaudited financial results for the guarter ended June 30, 2021 has been carried out by the statutory auditors and have issued an unqualified review conclusion thereon.
- The said financial results have been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standards notified under Section 133 of the Companies Act, 2013 read with relevant Rules issued thereunder and other accounting principles generally accepted in India.
- The Company operates mainly in the business of lending finance, accordingly there are no separate reportable segments as per IND AS 108 - Operating Segments.
- The Standalone financial statements for the quarter ended June 30, 2021 have been taken on record by the Board of Directors at its meeting held on August 13, 2021. The Statutory Auditors have expressed an unqualified review conclusion on the financial results for the quarter ended June 30, 2021. These Standalone financial results have been extracted from the unaudited Financial statements.
- The statement includes the results for the quarters ended March 31, 2021 being the balancing figure of the audited figures in respect of full financial year and the published year to date figures up to the third quarter of the respective financial year, the results which were subjected to "Limited Review".
- Covid-19 Pandemic continues to spread across several countries including India resulting in a significant volatility in Global as well as Indian financial markets and a significant decline in global and local economic activities. The current 'second wave' of Covid-19 situation continues to be uncertain and the Company is evaluating the situation on an ongoing basis. The Company has made a prudential estimate of provision for expected credit loss on financial assets as at 30th June 2021. The Company's capital and liquidity position is strong and would continue to be the focus area during this period.
- Previous period figures have been regrouped/reclassified, wherever necessary, to conform with the current period presentation.
