

Dear Shareholder,

The Securities and Exchange Board of India (SEBI) vide SEBI (Listing Obligations and Disclosure Requirements) (Fourth Amendment) Regulations, 2018 dated 8th June, 2018 states that, "Provided that, except in case of transmission and transposition of securities, requests for effecting transfer of securities shall not be processed unless the securities are held in the dematerialized form with a depository."

In compliance to the said amendment, applicable from December 05, 2018, the Company or its Registrar and Transfer Agents – M/s Link Intime India Pvt. Ltd will not be accepting any request for transfer of Shares, if it is in Physical form and presented for transfer on or after December 05, 2018.

The shareholders are advised that to facilitate transfer of shares of the Company, the same are required to be dematerialized. The key steps involved in dematerializing shares are:

- 1. Open a demat account with a Depository Participant (DP);
- Submit physical share certificate(s) to the DP along with a Demat Request Form (DRF);
- 3. DP would inform the Depository (NSDL or CDSL) regarding the demat request;
- 4. The DP would thereafter submit the share certificate(s) along with DRF to the Registrar of the Company;
- The Registrar would validate the documents and convey acceptance/rejection of the demat request to the concerned Depository;
- 6. Upon successful dematerialization of the share(s), the Registrar would update the Registrar of Members;
- The concerned Depository would also update its record and inform the DP; and 8. The DP would then credit the share(s) into the demat account of the investor
