**Mandatory** breathalyser test for aviation officials, other than pilots and engineers.

The breathalyser test is used to detect if the crew is tipsy while reporting for duty.

In January-October 2018, the breathalyser test violation per 10,000 (flight) departures was 2.01. In 2015-2017, the figures were 2.57, 2.44, and 2.46, respectively.

According to the recommendations of the International Civil Aviation Organization, the level of

are randomly subjected to breathalyser examination on a daily basis. Aerodrome management shall also be responsible for conduct of test on the personnel of the ground handling agency and aerodrome operational personnel," a draft proposal issued by Indian aviation regulator DGCA said.

While licensed personnel like ATCOs will have their licence suspended for three months and be grounded for this period for failing the breathalyser test first time or

pending for three years and the fourth time will lead to cancellation of licence.

"It is imperative to ensure that all those involved in day-to-day process of making an aircraft fly safe are not drunk. Like ATC officials operate the system to expedite and maintain a safe and orderly flow of air traffic and help prevent mid-air collisions. They apply separation rules to keep each aircraft apart from others in their area. Similarly, those who work on the airside and come in contact with the aircraft are very critical to the safety of the aviation ecosystem," said a DGCA official.

## Tesla under probe by US agency over safety claims

The US National Highway Traffic Administration sent Tesla Inc.'s Elon Musk a cease-and-desist letter last year regarding Model 3 safety claims and has subpoenaed the carmaker for information on several crashes, according to documents posted by a nonprofit advocacy group.

NHTSA lawyers took issue with an October 7 Tesla blog post that said the Model 3 had achieved the lowest probability of injury of any vehicle the agency ever tested, the documents released Tuesday by the legal transparency group Plainsite show. The regulator said the claims were inconsistent with its advertising guidelines regarding crash ratings

and that it would ask the Federal Trade Commission to investigate whether the statements were unfair or deceptive acts. The documents, obtained through a Freedom of Information Act request, also include orders for information that NHTSA sent to Tesla following several crashes, including a fatal March 1 crash involving a Model 3 operating on Autopilot. Tesla shares fell as much as 2.1 per cent to \$225.80 shortly after the open of regular trading Wednesday.

"If it's a subpoena, it's known to get quicker attention from the manufacturer generally, and it's not a routine matter," said Allan Kam, an independent auto-safety consultant who retired as a senior enforcement attorney at NHTSA in 2000.
