पुण्यात भटक्या श्वानाची डोक्यात रॉड घालून हत्या

पुणे, दि. १३, (प्रतिनिधी) : शहरात सातत्याने स्थानिक नागरिक व प्राणीप्रेमी यांच्यात भटक्या कुत्र्यांवरून वाद होत असतात. या वादांचे रूपांतर अनेकदा भांडणातही होते. अशी एक घटना पुण्यात घडली आहे. दत्तवाडी परिसरात राणी गावाच्या भटक्या श्वानाची डोक्यात रॉडने हल्ला करत हत्या केव्याची घटना घडली आहे.

प्राणींनो प्रेमींनी दिलेल्या तक्रारीनंतर श्वान हत्या प्रकरणही दत्तवाडी पोलिस स्टेशनमध्ये गुन्हा दाखल करण्यात आला आहे. याप्रकरणी आरोपी अमील खेडकर (रा. दत्तवाडी) याच्याविरुद्ध कलम 42४ अंतर्गत गुन्हा दाखल करण्यात आला आहे. भारतीय अशोक सांठ्ळेके (52 वर्षीय महिलेने या प्रकरणी दत्तवाडी पोलिस ठाण्यात फिर्याद दिली आहे. दत्तवाडी परिसरात गेल्या अनेक वर्षांपासून राणीगावाचे कुत्रे वास्तव्यास होते. मागील काही दिवसांपासून ते आजारी असल्याने विव्दळ होते. त्याच्या या विव्दळप्याचा त्रास आरोपीला होत होता. या रागातूनच आरोपींनी तिच्या डोक्यात लोखंडी रॉडने प्रहार केले. यामध्ये गंभीर जखमी झाल्याने तिला बावधन येथील निमल रेस्क्यू फाउंडेशनमध्ये उपचारासाठी दाखल करण्यात आले होते. परंतु उपचार सुरू असताना या कुत्र्याचा मृत्यू झाला. दत्तवाडी पोलिसांनी या प्रकरणी गुन्हा दाखल केला असून अधिक तपास सुरू आहे. दुसरीकडे नागापूरमध्ये भटक्या कुत्र्याच्या शेपटीला वात्रट युवकांनी फटाके बांधल्याचा धक्कादायक व्हिडीओ समोर आला आहे.
