Pursuant to Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, (“**SEBI LODR Regulations**”) this is to inform you that the Board of Directors of the Company vide circular resolution passed on March 30, 2023 has approved the allotment of 72,826 equity shares of face value of Rs. 10/- each to eligible Employees upon Exercise of vested option under Employee Stock Option Plan 2011 (“**ESOP 2011**”) and Employee Stock Option Plan 2015 (“**ESOP 2015**”).

Consequent to this allotment, the paid-up share capital of the Company stands increased from Rs. 467,714,910/- (consisting of 46,771,491 equity shares of face value of Rs. 10/- each) to Rs. 468,443,170/- (consisting of 46,844,317 equity shares of face value of Rs. 10/- each).
