SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, we wish to inform that the Hon'ble NCLT, Mumbai Bench by an Order orally pronounced today i.e. December 08, 2023 has approved the Resolution Plan in respect of the Company.
