# Muslims being targeted in UP, framedinfalsecases: Mayawati

Bahujan Samaj Party chief Mayawati today alleged that besides Brahmins and Dalits, Muslims are being targeted under the BJP regime in Uttar Pradesh. She also flayed incidents of vandalising idols of B R Ambedkar in the state and asked the government to take appropriate steps. "In SP government, Brahmins and Dalits were oppressed selectively. Now in the present BJP government, along with them, there is a lot of oppression of Muslims as well. They are being framed in false cases, which is very sad," Mayawati charged in a series of tweets in Hindi. "Idols of the messiah of Dalits - Baba Saheb Dr. Bhimrao Ambedkar - great

in the last several days, with Chief Minister Arvind Kejriwal announcing last month that COVID-19 tests in Delhi will be doubled to 40,000 perday within a week as there has been a marginal increase in the number of cases. In the last week of August amid a spike in cases, Kejriwal had warned people against complacency and said that more and more people should get themselves tested if they observe coronavirus symptoms "Due overconfidence, people think they will recover even after they have symptoms. They do not realise that if they do not get tested in time, they end up infecting many people around them eventually. People can avail testing for free in any government hospital or government dispensary," he said. He asked people to get themselves tested, wear masks, and practice social

experts pointed out that the of contracting fear coronavirus has reduced among patients, and they said they were seeing lower footfall in hospitals. Manoj Sharma, Senior Consultant, Medicine and Incharge at Medeor Hospital Qutab Institutional Area, said the hospital witnessed lesser footfall of patients for coronavirus tests on days of incessant rains which led to floodinginsomeareasandon festivals or holidays like Independence Day, Janmasthami. "Earlier, there was a lot of panic and even for minor symptoms people were coming to hospitals. But now, they think that if they have minor symptoms they will recover. There is some
