## **HC Restrains ED from** ... Taking Coercive Steps Against Piramal Assets

Court also restrains co from disposing of or creating third-party □ rights till next hearing.

New Delhi: The Delhi High Co-Furt last week restrained the Directorate of Enforcement (ED) from taking coercive steps against properties worth ₹410 crore of M/s Piramal Realty Pvt Ltd that the federal agency had provisionally attached in January. ED has alleged that Omkar Group took a Rs 410 crore loan from Yes Bank to construct buil-A dings for slum dwellers under <u>=</u>the Slum Rehabilitation Autho-Erity (SRA) scheme at Wadala (in Mumbai) but redirected the mo-Eney to other companies.

The agency is probing an alleged ₹22,000 crore SRA scandal by the promoters of Omkar Realtors and Developers (Omkar), Kamal Gupta and Babulal Ver-Ema. It has recently trained its fo--cus on their association with the EPiramal Group's real estate arm. The high court has also rest-Erained the petitioner company (Piramal Realty) from "disposing of or creating third-party rights or encumbering" the property till the next date of hearing, January 18.

Omkar's promoters were charged under various sections of the N\_Prevention of Money Laundeand availing loans worth Rs creditor. 22,000 crore which were then diverted or siphoned.

# HC Quashes FIR Against ICICI, Others in Alleged Fraud Case

Hotelier's complaint of being coaxed to mortgage property for loan without merit, rules court

Mumbai: The Bombay High Court on Monday quashed a first information report filed by a hotelier and subsequ-Eent investigation by the Economic Offences Wing (EOW) of the Mumbai Po--lice against ICICI Bank, some of its senior executives and JM Financial Asset Reconstruction Company, a lawyer who represented the bank said.

The bank and the executives, including four former bankers, had approa-Eched the court to quash the FIR, registered in 2021, and the proceedings initiated by the police.

"The court saw through the complaint and concluded that it was sans me-Frit and allowed our petition, thereby quashing the frivolous complaint registered by the EOW. This order could set a precedent especially in cases where frivolous cases are being filed by defaulters to implicate senior-most banking officials to settle scores," said Zulfiquar Memon of MZM Legal. While Sharma made a request of ₹65 crore to be disbursed as the first instalment of the loan, the bankers who were part of the management committee submitted a "false proposal note" before the credit committee for an immediate disbursement of ₹25 crore, the FIR claimed. The bank deducted ₹15.5 crore from this towards processing fees and Sharma received ₹9.5 crore, it said.

Sharma alleged that he was later coaxed by the bank executives to pay ₹47.37 crore as dues. "In the event this amount isn't paid, then the processing fee amount and interest won't be returned," he was told, as per the FIR.

In September 2016, he had said, the loan was sold to the ARC. The ARC then raised a demand of ₹120 crore from the complainant, the FIR said.

"They also told us that from the recovered amount, 80% would be paid to ICICI Bank, While the bank disbursed ₹9.5 crore, it was demanding ₹120 crore," the FIR had claimed.

He filed the complaint at the BKC police station from where it was transferred in 2021 to the EOW and the FIR was filed. The bank then moved the court.

Mumbai: IndiGo will fully restore salaries of its pilots to pre-Covid levels from November, the head of flight operations wrote to employees.

"Our aim has been to constantly revisit our salary and remuneration and reinstate them to pre-Covid levels. Keeping that in mind, I am pleased to announce a further 6% reinstatement of salaries effective September 1, 2022 and the remaining 6% shall be reinstated on November 1, 2022 as we all welcome the festival of lights. These reinstatements will bring your salaries at par with pre-Covid level," Ashim Mittra wrote to pilots in an email Monday.

Last month, he said IndiGo would increase its pilot salaries by 8% from August, reacting to their demands to reinstate remuneration to pre-Covid levels. The airline increased salaries by 8% on March 31.

"In these last few months, we have been monitoring our recovery constantly and while we were earlier planning to reinstate 6.5% salaries in November 2022, owing to steady operations, we could enhance and advance that to 8% reinstatement, with effect from August 1, 2022. As communicated previously, this change shall reflect in your August salaries," Mittra wrote in this letter Monday. The airline has also enhanced other incentives such as layover allowance, to pre-Covid levels.

A large chunk of IndiGo's employees remained away from work recently, leading to delays in more than half of

### Delhi hotels, bars unable to serve alcohol

estaurants and bars across Delhi were left high and dry on Monday, a day after the expiry of their excise licences.

Vikrant Batra, co-founder and director, Batra Bros Food and Beverages, said the policy was expected to be extended for a month but no new notification was received till Monday evening.

"Our licenses expired at midnight on July 31. While we are expecting to hear from the excise department soon, so far, we have not. We have already had a day's revenue lost from the lack of alcohol sales along with cancellations from several guests who wanted to do larger events in Delhi," he said.

Batra runs popular chain Cafe Delhi Heights, which has close to 10 outlets in Delhi Another bar owner said they

were simply caught in a crossfire between the Union government and the state.

"We don't know how to proceed. The Delhi government decided to roll it back and we are suffering at the hands of a policy paralysis. Haryana, on the other hand, which has a BJP-led government has an even more liberal excise policy where even vends can sell up till 8 am, so why is Delhi being singled out? What do we do with all the alcohol we have stocked up already?," the person said requesting anonym-

On 30 July, Delhi's deputy chief minister Manish Sisodia told reporters that the state government had withdrawn its new excise policy that came into force last October.

# Local OTT platforms battle rising costs of production

Bills are mounting as actors, writers and directors charge more as bigger platforms pay more

he streaming business is getting expensive for homegrown over-the-top (OTT) video platforms competing for eyeballs with well-funded global companies such as Netflix, Amazon Prime Video and Disney+Hotstar.

While American firms with deep pockets have kept pace with the rising costs of producing web originals, smaller OTT platforms said it is a challenge considering the mounting bills as actors, writers and directors charge more and more as bigger platforms loosen their purse strings. Viewers, too, expect superior quality, requiring higher investments.

"With production costs on the rise, one challenge we are faced with is justifying every piece of content that is on the platform. So, we are extremely picky with what we greenlight. Until and unless we feel there is an X-factor to the project or the required strength to provide audiences with quality entertainment, we abstain from it," said Soumya Mukherjee, chief operating officer of Hoichoi, a Bengali platform.

Smaller homegrown platforms invest ₹3 crore-₹4 crore per season compared to ₹40 crore-₹50 crore of marquee shows of foreign players. The key is to remain hyperlocal and woo audiences speaking a native language with strong, nuanced stories, said industry experts. Furthermore, they are tapping talented newcomers who are prepared to settle for lower remuneration.

"A lot of inflation within the OTT industry is demand-led," said Ajit Thakur, chief executive officer of Telugu service Aha Video. "Catering to a wider audience base requires making content consistently.

"We may not be looking at many

high-budget shows but we bring out small and medium-budget shows frequently and have found partners in the industry thanks to our local positioning and reach," Thakur said. "The budgets of some shows commissioned by foreign OTT firms are unsustainable.'

There is no dearth of acting talent for OTTs and there will be multiple takers for any opportunity, said Akshay Bardapurkar, founder of OTT platform Planet Marathi, who has upped his own budgets from \$50 lakh per season to now \$2crore-₹5 crore. Other than rooted, hyperlocal content, Bardapurkar said it is important for regional platforms to invest in marketing and promotion, besides distribution tie-ups with telcos and aggregators which bring them good

Bigger OTT players get strong support from their parent group that gives them access to a larger pool of funds and dedicated in-house content development teams, said Indrajeet Mookerjee, managing partner at media agency dentsuMB India and regional players primarily prefer outsourcing production while maintaining a strong

hold on the final output. Sidharth Singh, co-founder of mar-

keting agency CupShup said there is sizeable Indian diaspora that yearns local content and these OTT platforms stand out on that front.

## Kama Ayurveda to open stores abroad, starting with UK

kincare and beauty brand Kama Ayurveda is looking to expand outside India and plans to start with the UK as a "test market" in 2023, co-founder and chief executive Vivek Sahni said. Later, it will look to expand to other locations in Europe and the US.

Within India, Kama Ayurveda Pvt. Ltd will add 10 stores this fiscal year to its existing 57. These include the one in Gwalior that opened earlier this week; one each in Bareilly. Thiruvanathapuram, Ranchi, Siliguri, Jodhpur, and two in Goa. The company also works on a shop-in-shop model and has 70 such outlets with retailers like Shoppers Stop. It shut down eight stores during the pandemic in cities like Raipur and Amritsar where the outlets were present at airports.

In 2019, Spanish perfume maker Puig, known for brands such as Prada and

Paco Rabanne, invested ₹100 crore in Kama for a minority stake. "The reason we partnered with them-they are a airports strategic partner too-was that we could take the

brand abroad. Of course, then the pandemic hit. But now that things are coming back, we have a timeline that by spring next year, we will have opened our first store in the UK. This will be a standalone store and it will also have an online sales platform," Sahni said.

The company has also received funding of an undisclosed amount from Light house. In July 2021, it started


