#### Sub: **Decisions taken at the Board Meeting**

In continuation to the letter dated 3rd August 2022 from Gujarat Pipavav Port Limited ('the Company') intimating about approval of the Unaudited Statement of Accounts for the Quarter ended 30th June 2022, kindly note the Board of Directors of the Company have inter alia also approved the following in the Meeting held today:

### Appointment of Ms. Matangi Gowrishankar (DIN: 01518137) as Independent Director:

The Board of Directors have approved the Appointment of Ms. Matangi Gowrishankar as an Independent Director of the Company. Subject to approval of shareholders, Ms. Gowrishankar has been appointed for a period of five years from 3<sup>rd</sup> August 2022 to 2<sup>nd</sup> August 2027. Ms. Gowrishankar has also been appointed as a Member of the Nomination & Remuneration Committee of the Company.

Ms. Matangi Gowrishankar is a Senior HR Leader. Ms. Gowrishankar has expertise in the areas of Leadership & Organization development and in Diversity & Inclusion, with a deep commitment to help organizations and teams achieve their strategic intent through people and strong people processes. She is supporting companies to build strategic HR practices for sustainable growth in their fields.

Ms. Gowrishankar is a Graduate in Sociology from Madras University and an MBA in Personnel Management and Industrial Relations from Xavier Labour Relations Institute (XLRI), Jamshedpur.
