Imagicaaworld Entertainment Ltd reports Q2 FY22 Results

Mumbai, Oct 29, 2021: Imagicaaworld Entertainment Limited, which operates Imagicaa - Theme Park, Water Park, Snow Park and a family hotel Novotel Imagicaa Khopoli, announced its unaudited Financial Results for the Quarter ending 30th September 2021.

In Q2 FY22, the Park operations remained closed on account of the second phase of lockdown and restrictions. However, the Company saw an upswing in the Hotel business which reported revenues of Rs. 4.6 Crs in Q2 FY22, as consumers started to look for outdoor recreation avenues.

The company reported operating expenses (excluding interest and depreciation) of Rs. 14.2 Crs in Q2 FY22 vis-a-vis Rs. 8.2 Crs in Q2 FY21. The increase in costs was primarily from increase in repairs & maintenance and power & fuel expenses, as the company initiated readiness for reopening of park operations. Further, the hotel expenses increased due to an increase in rooms sold.

Developments on account of Covid 19

As Maharashtra was hit by the second wave, the State imposed lockdown II, leading to closure of park operations from 5th Apr 2021 and have remain closed for the remainder of Q2 FY22.

Industry Associations such as IAAPI and RAI have made representations to the State Government for re-opening amusement parks. On 18th October 2021, Govt. of Maharashtra, announced to allow amusement parks (except water park/rides) to open from 22nd October 2021.

Accordingly, Imagicaa has reopened the flagship Theme park from 22nd October 2021.
