The company as a rule report all the material events to the Stock Exchange as and when such events take place to comply with Regulation 30 of SEBI (LODR) Regulations, 2015.

- 1. In the recent past there were few developments which were duly reported to the Stock Exchange immediately on completion of the Board meeting.
- 2. On 25th May, 2023 we have reported in our Stock Exchange filing about the proposal to merge 2 of the subsidiary Companies, namely Accel OEM appliances Limited and Accel Media Ventures limited with itself. After the Committee of Independent directors giving their final report, the Board had approved the proposal in their meeting held on 7th July, 2023 and the same was reported to the BSE on the same day. Further actions are being initiated as per the filing made to the exchange on 7th July, 2023 to implement the merger proposal.
- 3. Subsequent to the above development, we wish to state that, our warranty services division received an in-principle approval on 11th July, 2023 to become an independent service provider for one of worlds topmost brand of Mobile Phones in 20 Cities of India, for which efforts will be initiated for speedy implementation. Further developments in this regard will be communicated as and when it happens.
