Gas Based Station-I, mainly due to increase in Natural Gas Price.

Dear Sir / Madam,

With reference to the captioned subject, and pursuant to the Regulation 30(3) read with Para B of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (LODR), we would like to inform that:

- The Company has 145 MW Combined Cycle Power Plant, Gas Based Station-I situated at Vadodara which uses Natural Gas as its Fuel for generation of power.
- It has been observed that the Natural Gas Price has been showing increasing trend since middle of the current Financial Year and even more predominantly since February, 2022, with beginning of issues (including war) between Russia and Ukraine. The same is impacting the gas availability / feasibility for running operations of the subject Station-1.
- Due to the aforesaid reasons, the power generation from this plant and the operations have been affected. The plant is non-operational and may resume operations once the gas prices are back to normal levels.
- The Company is making all possible efforts for sourcing cheaper gas to make the plant operational, however looking to the present global situation on gas prices, overall demand - supply scenario as well as the Government priorities for allocation of domestic gas, there seems less likelihood of resumption of power generation from the subject plant in near future.
