SUMMARY OF PROCEEDINGS OF 52nd ANNUAL GENERAL MEETING

The 52nd Annual General Meeting of the Members of the Company was held on 15th November, 2021 at 11.00 a.m. through Video Conference (VC) / Other Audio Visual Means (OAVM).

Shri. M. Nandagopal, Executive Chairman chaired the proceedings of the Meeting.

The number of shareholders as on record date 8th November, 2021 were 10850.

The details of number of shareholders present in the meeting are as follows:

The Chairman called the meeting to order as requisite quorum was present.

The Chairman introduced the Directors, Management Committee Members and the invitees present at the meeting.

The Chairman introduced Smt. Madhaneswari Nandagopal, who was appointed as a Non-executive Director and Shri. T Krishnamurthy Who was appointed as Whole-time Director and designated as Director (Finance) & CFO of the Company.

The Chairman informed that in view of the restrictions due to outbreak of COVID-19 and considering the social distancing norms, the AGM was conducted through VC / OAVM. This meeting has been convened and being conducted in accordance with the circulars issued by Ministry of Corporate Affairs and Securities and Exchange Board of India (SEBI).

The Chairman informed that the Company had tied up with Central Depository Services (India) Limited (CDSL) to provide facility for voting through remote e-voting, e-voting during the AGM and participation in the AGM through VC / OAVM facility.

The Chairman informed the Members that the Report of Board of Directors, the Accounts for the financial year ended 31st March, 2021 and the Notice convening the 52nd AGM were taken as read as the same had already been circulated to the Members.

As there were no qualifications in the Audit Report, it was not required to be read.

The Chairman informed the Members that pursuant to the provisions of the Companies Act, 2013, the Rules framed thereunder and the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had extended the remote e-voting facility to the Members of the Company in respect of the resolutions to be passed at the Meeting. The remote e-voting commenced at 9.00 a.m. on Friday, 12th November, 2021 and ended at 5.00 p.m. on Sunday, 14th November, 2021.
