Watch daring act by a railway employee who saves man on the tracks seconds before train passes them by



Chandigarh. The Ministry of Railways has put out a tweet praising the bravery of one of its employees who saved the life of a man who was lying on the railway track seconds before a train passed by.

The tweet says, "A precious life was saved by the courageous act of help by on-duty staff, who jumped on tracks himself to save a person from getting gravely injured. Indian Railways is proud to have daring & diligent staff like H. Satish Kumar and commends his bravery."

The incident took place at a railway station in West Bengal where Satish Kumar was showing the green flag to an approaching train when he noticed a man lying on the tracks. He sprinted a fair distance, jumped down the platform, got hold of the man and took him to safety seconds before the train passed them by.

He has received a lot of praise on the Twitter where people have demanded a cash reward for the daring act by the brave man, who went beyond the call of duty to save a life.

47th anniversary of **Emergency in India:** What exactly happened on June 25, 1975? Why did Indira Gandhi take such a step?

New Delhi. On this day (June 25), 47 years ago, former Prime Minister Indira Gandhi had imposed a nationwide state emergency which went down as one of the most notorious events in Indian history. It curtailed restrictions on civil liberties, press freedom and led to crackdowns against the Congress' political oppositions. The order for imposing the Emergency was issued by President Fakhruddin Ali under Article 352 of the

Why did Indira Gandhi impose Emergency in 1975?

He cited 'internal disturbances' as the reason for invoking the order which cancelled elections and gave the Prime Minister unprecedented powers. The Indira Gandhi government also reasoned that there were threats to national security which required such strict measures. At the time, a war with Pakistan had recently ended due to which the economy had suffered leading to protests and strikes. This, the government,

said that hurt the country to large extent. It is believed that the Emergency was imposed after the 1975 verdict of the Allahabad High Court which convicted Gandhi of electoral malpractices and disqualified her from the Parliament and stated that she won't be able to hold any elected post for the next 6 years. Soon after this verdict, she had declared the Emergency.


